

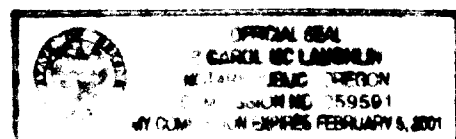
NARRATIVE

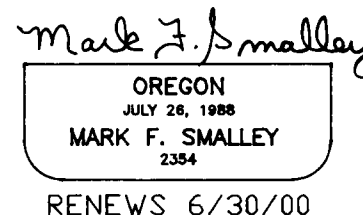
