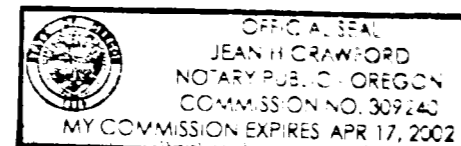

### NARRATIVE:

The purpose of this survey is to demarcate the boundary of that property described in Deed Reference Number 99-22796 in compliance with conditional approval of an application for a Land Partition at the request of the property owners. Douglas County Planning Dept. file number P/D 99-289.

The Boundary was resolved as follows: The north line was determined by holding the monumentation found delineating the south line of Ewens' Acres as shown. The east line was established by holding the monument found at the SW corner of Lot 3, Block 1, Roseburg Home Orchard Tracts, Plat "B" and the monument found at the SE corner of said Ewens' Acres. The west line was determined by holding the monument found at the SW corner of said Ewens' Acres and the monument found at the NW corner of Lot 4, Block 4, R.H.O.T., Plat "B". Said west line also being the east Right-Of-Way Line of County Road No. 6. The south line of the subject tract was calculated by holding the monument set by Boughman on the south line of Lot 3, Block 1, said subdivision, as shown in survey M 52-20 and projecting that line west to intersect with the Right-Of-Way line previously determined. The Parcel lines were at the discretion of the property owners and monuments were set as shown.
