**NARRATIVE**

THE PURPOSE OF THIS SURVEY IS TO DIVIDE INTO 3 PARCELS THE PROPERTY DESCRIBED IN THE SURVEYORS CERTIFICATION ABOVE. DISCREPANCIES BETWEEN THE LINES OF OCCUPANCY AND DEED LINES WERE FOUND ALONG THE NORTH AND EAST BOUNDARIES; THEREFORE THESE LINES WERE ADJUSTED TO FIT THE LINES OF OCCUPANCY AND A NEW DESCRIPTION WAS WRITTEN AS REFLECTED IN THE SURVEYORS CERTIFICATION. THE WEST BOUNDARY WAS ESTABLISHED ALONG THE NORTH-SOUTH CENTERLINE OF SECTION 8. THE SOUTH BOUNDARY WAS ESTABLISHED ALONG THE EAST-WEST CENTERLINE OF SECTION 8. THE MOST EASTERLY BOUNDARY WAS ESTABLISHED BY HOLDING THE PIN AT THE NORTHWEST CORNER OF LOT 5, BLOCK 6, KREWSON'S ADDITION AND PROJECTING THE WESTERLY BOUNDARY OF SAID SUBDIVISION, NORTHERLY, INTERSECTING IT WITH KREWSON STREET. INTERIOR MONUMENTS WERE SET AT THE DIRECTION OF THE OWNER AND SHOWN HEREON.

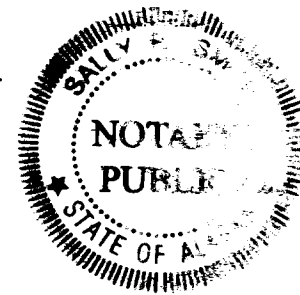

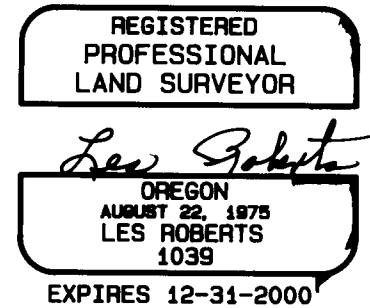
