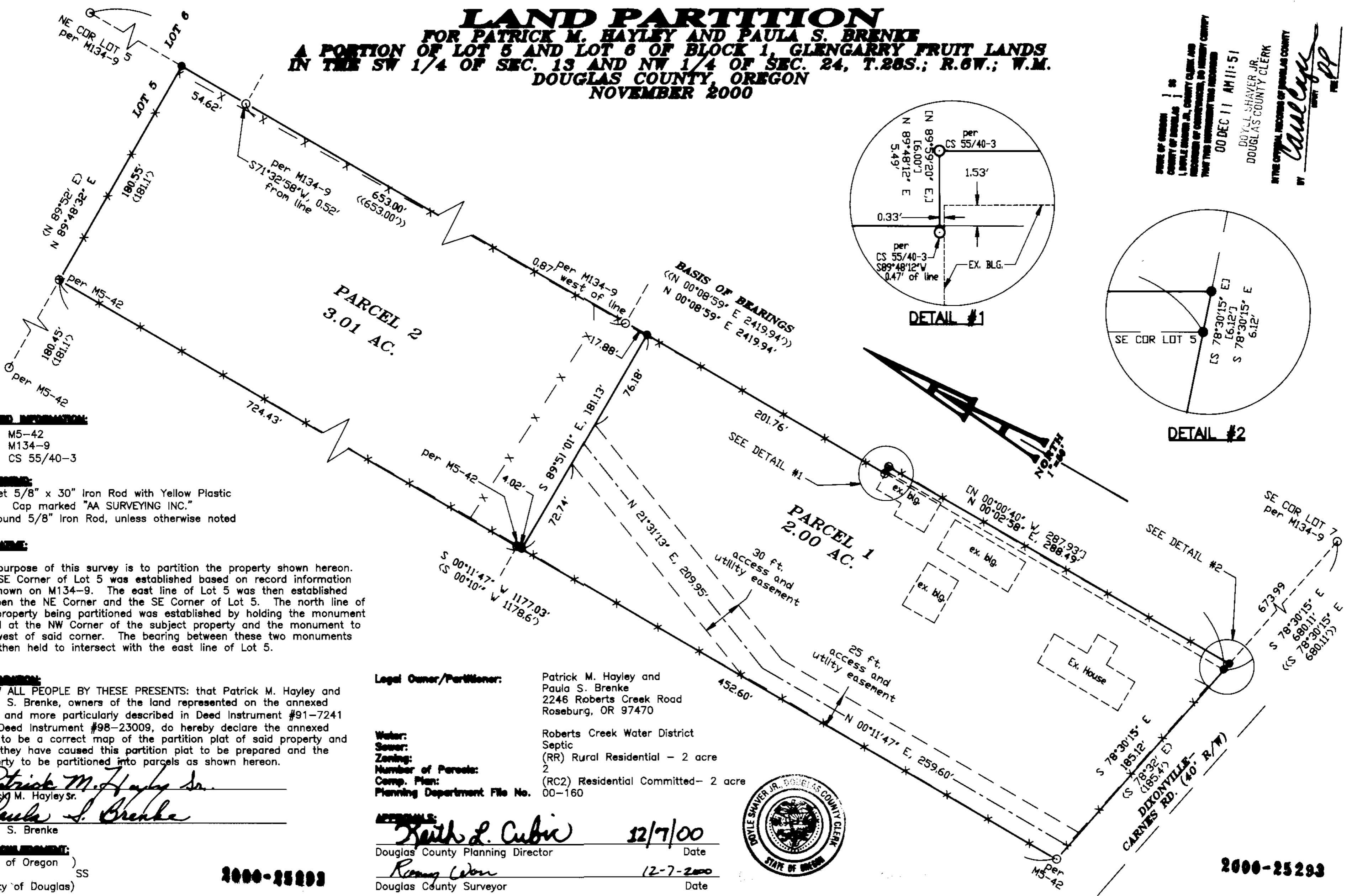

The purpose of this survey is to partition the property shown hereon. The SE Corner of Lot 5 was established based on record information as shown on M134-9. The east line of Lot 5 was then established between the NE Corner and the SE Corner of Lot 5. The north line of the property being partitioned was established by holding the monument found at the NW Corner of the subject property and the monument to the west of said corner. The bearing between these two monuments was then held to intersect with the east line of Lot 5.

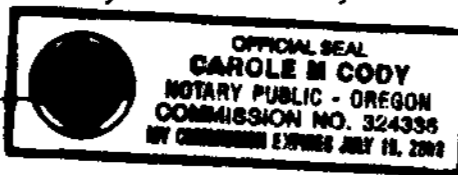

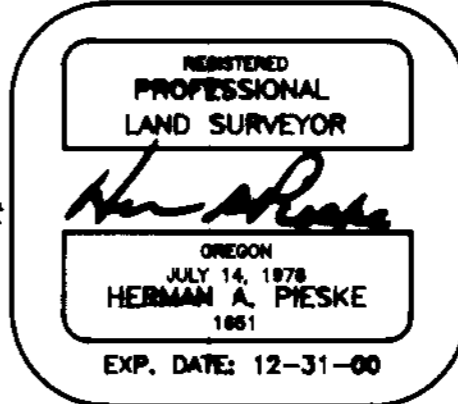
