NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO PARTITION A 1 ACRE PARCEL OFF OF THE PARENT PARCEL AS SHOWN. THE TWO FOUND MONUMENTS ON THE WESTERLY BOUNDARY OF THAT LAND DESCRIBED IN INSTRUMENT NO. 79-06598 WERE USED AS A BASE OF BEARING. THE FENCE RUNNING THROUGH THESE MONUMENTS AND ON TO THE NORTH WAS VERY STRAIGHT. THE DISTANCES CALLED FOR FROM THE COUNTY ROAD TO THE FENCE ON THE SOUTHERLY BOUNDARY DISAGREED SUBSTANTIALLY FROM WHAT EXISTED IN THE FIELD SO I WENT TO THE DESCRIPTION AS GIVEN IN INSTRUMENT NO. 78-12285, RAN NORTHERLY FROM THE SOUTHWEST CORNER OF D.L.C. 45 AND THEN AROUND TO THE SOUTHERLY LINE OF WHAT WAS LATER SOLD PER INSTRUMENT NO. 79-04801. (THE LEGAL DESCRIPTION USED IN INSTRUMENT NO. 79-04801 BEING USED AS A BASIS FOR INSTRUMENT NO. 87-11741). DOING THIS, THE LEGAL DESCRIPTION HIT WITHIN APPROXIMATELY THREE FEET OF THE EXISTING FENCE AND THE DISTANCE ACROSS THE SOUTHERLY END OF THIS PARCEL IS WITHIN 1.4 FEET. FOUR SHOTS ALONG THE EXISTING WESTERLY FENCE SHOWED IT TO BE VERY STRAIGHT AND IN A LONG ESTABLISHED LOCATION SO WAS HELD FOR LINE.
