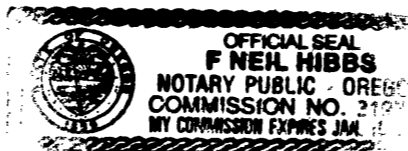

NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO PARTITION THAT LAND DESCRIBED ABOVE INTO THREE PARCELS TOGETHER WITH EASEMENTS AS SHOWN. COMPUTED LINE "A-B" WAS USED AS A BASE OF BEARING. THE SURVEY RECORDED AS M36-70 WAS RE-CREATED CLOCKWISE FROM POINT "A", AROUND TO POINT "B". POINT "C" WAS CREATED AT RECORD BEARING AND DISTANCE FROM POINT "D". THE FIRST COURSE SOUTHERLY OF POINT "B" WAS RUN AT RECORD BEARING AND DISTANCE. FROM POINT "C", RECORD BEARINGS AND DISTANCES WERE USED FOR THE FIRST TWO COURSES, THEN RAN TO THE FOUND MONUMENT AT POINT "E". POINT "F" WAS SET AT RECORD DISTANCE FROM POINT "E" PER SURVEY M76-64.
