**NARRATIVE:**

THE PURPOSE OF THIS SURVEY WAS TO PARTITION THE BARRON PROPERTY INTO 3 PARCELS AS APPROVED UNDER DOUGLAS COUNTY PLANNING DEPARTMENT FILE NO. 02-008. THIS SURVEY IS AN EXTENSION OF SURVEY WORK PERFORMED UNDER M 138-73. THE WEST LINE WAS SURVEYED UNDER M 138-73. THE NORTH LINE AND EAST LINE OF PARCEL 3 AND THE NORTH LINE OF THE LOT OF RECORD WAS CONTROLLED BY EXISTING FENCE LINES. DEEDS ARE BEING PREPARED TO ADJUST THE BOUNDARY LINES TO THESE EXISTING LONG STANDING FENCE LINES. BUCKHORN COUNTY ROAD NO. 17 WAS CONTROLLED BY MONUMENTS FOUND PER 1964 ROAD PLANS. THE SUBDIVISION OF SECTION 31 WAS COMPUTED FROM CONTROLLING CORNERS FOUND AT THE NE, NW, SW, S 1/4 AND E 1/4 CORNERS OF SECTION 31. THE ORIGINAL NW CORNER OF SECTION 31 WAS RECOVERED AND REMONUMENTED UNDER THIS SURVEY. THE N 1/4 AND W 1/4 CORNERS WERE NOT RECOVERED AND PROPORTIONATE POSITIONS WERE COMPUTED FOR THESE CORNERS. THE N 1/16 CORNER OF SECTIONS 31 & 32 WAS ESTABLISHED AND THE NORTH LINE OF PARCEL 2 WAS MONUMENTED ON THE NORTH LINE OF GOVERNMENT LOT 10. THE SE CORNER OF SECTIONS 31 WAS COMPUTED AT THE INTERSECTION OF M 138-27 AND M 138-49 DISTANCES. THE SW CORNER OF PARCEL 2 WAS COMPUTED AT THE M 43-62 DISTANCE EAST OF THE S 1/4 CORNER OF SECTION 31 AND THE WEST LINE OF PARCEL 2 LYING SOUTH OF BUCKHORN ROAD WAS COMPUTED FROM THIS CORNER TO A FOUND M 43-62 MONUMENT. THE 30 FOOT ACCESS EASEMENT WAS SURVEYED ALONG THE CENTERLINE OF AN EXISTING ROADWAY.

THIS SURVEY WAS PERFORMED BY LES FANNING, MATT DIXON AND MICKEY CALVERT USING A NIKON DTM 531 AND SOKKIA SET 5A TOTAL STATION WITH COMPUTATIONS BY KRIS DEGROOT AND DRAFTING BY BILL WARREN.
