NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO PARTITION PARCEL OF LAND DESCRIBED IN VOLUME 98, PAGE 292, DOUGLAS COUNTY RECORD DEEDS.

THE PROCEDURE WAS AS FOLLOWS: WE TIED EXISTING MONUMENTS OF RECORD ALONG THE EAST RIGHT-OF-WAY BOUNDARY OF PEARCE ROAD. WE THEN CALCULATED THE WEST RIGHT-OF-WAY BOUNDARY OF PEARCE ROAD 60.00 FEET PERPENDICULAR AND PARALLEL TO TIED MONUMENTS. WE USED SAID WEST RIGHT-OF-WAY BOUNDARY TO DELINEATE THE EAST BOUNDARY OF PARCEL 2 OF THIS PARTITION. WE THEN TIED EXISTING MONUMENTS OF RECORD ALONG THE SOUTH RIGHT-OF-WAY BOUNDARY OF DOUGLAS AVE. TO DELINEATE THE NORTH BOUNDARY OF PARCEL 2 OF THIS PARTITION. THE WESTERLY AND SOUTH BOUNDARIES WERE LAYED OUT THROUGH THE PARENT PARCEL AS DIRECTED BY CLIENT.
