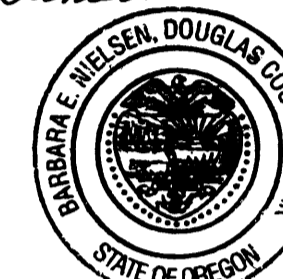

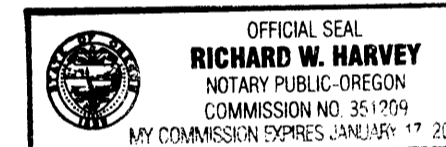

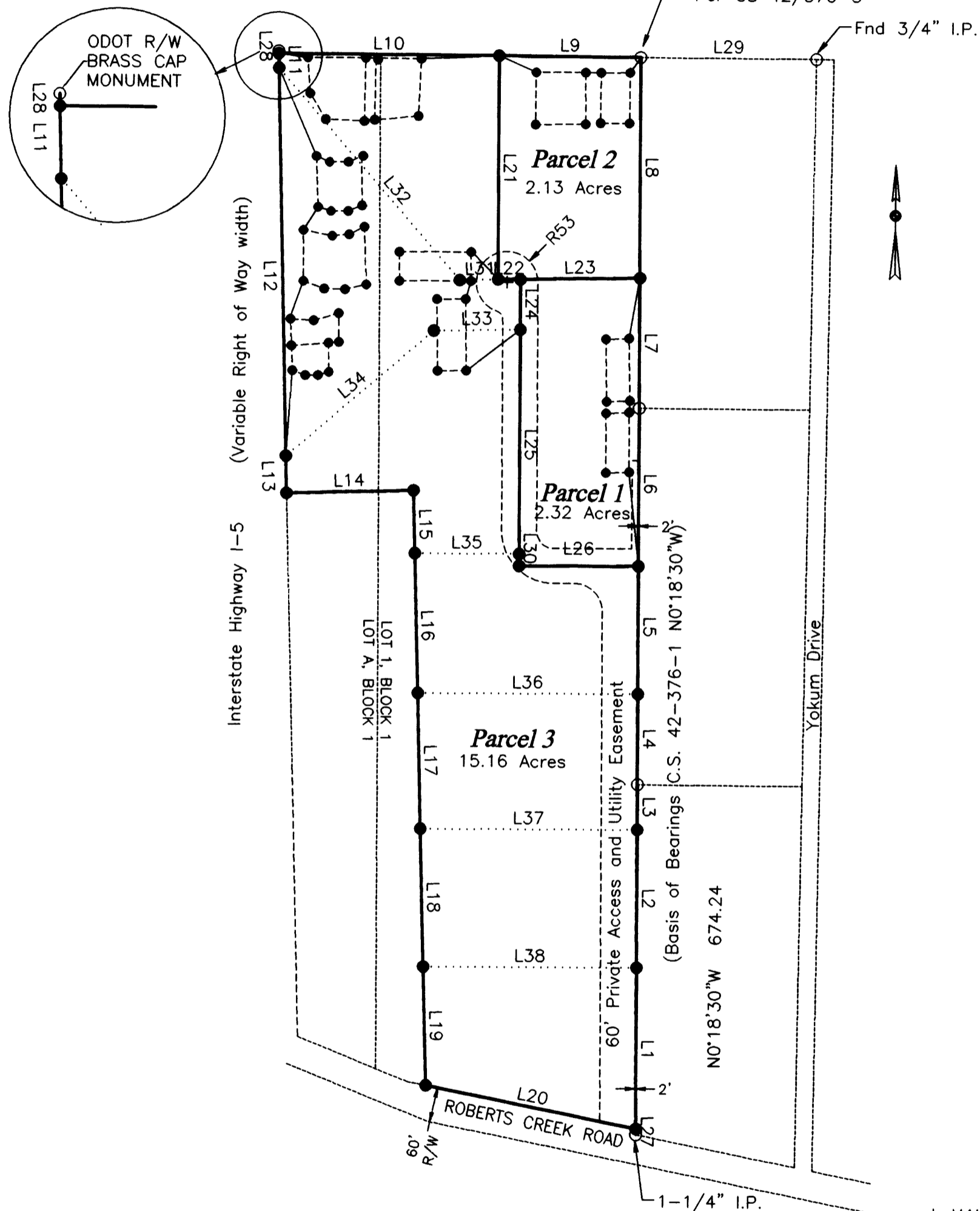

OF 2.32± ACRES, 2.13± ACRES AND 15.14± ACRES.

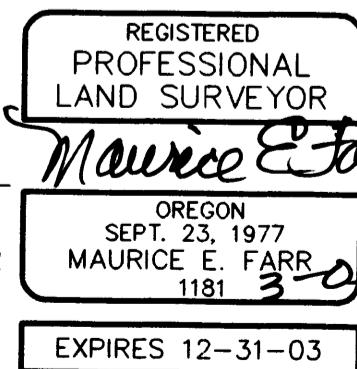
WE USED FOUND MONUMENTS FROM C.S. 42-376-1 TO CONTROL
