I, Mark Heimbürger, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the lands shown on this Partition Plat of which the following is a true and correct description:

Beginning at a 5/8 inch iron rod on the East West Centerline of Section 20, Township 27 South, Range 6 West, Willamette Meridian, from which the Quarter Section Corner common to said Section 20 and Section 21 bears North 89°47'44" East 1832.46 feet; thence North 10°20'04" East 492.28 feet to a 5/8 inch iron rod; thence 94.62 feet along the arc of a 50.00 foot radius non-tangent curve to the right, the chord of which bears North 26°04'59" East 81.13 feet to a 5/8 inch iron rod; thence North 26°18'48" East 8.40 feet to a 5/8 inch iron rod; thence North 32°02'37" West 566.15 feet to a 5/8 inch iron rod; thence South 21°21'30" West 151.38 feet to a 5/8 inch iron rod; South 77°47'23" West 189.43 feet to a 5/8 inch iron rod; thence South 15°42'25" West 376.87 feet to a 5/8 inch iron rod; thence South 20°19'41" East 533.71 feet to a 5/8 inch iron rod on said East-West Centerline of said Section 20; thence along said East West Centerline South 89°57'10" East 329.57 feet to the Point of Beginning, all situated in the Northeast 1/4, Section 20, Township 27 South, Range 6 West, Willamette Meridian, containing 10.07 acres more or less.

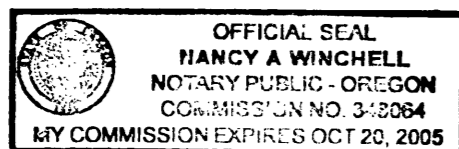

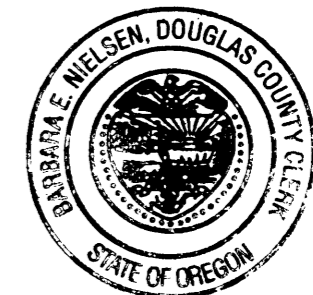
