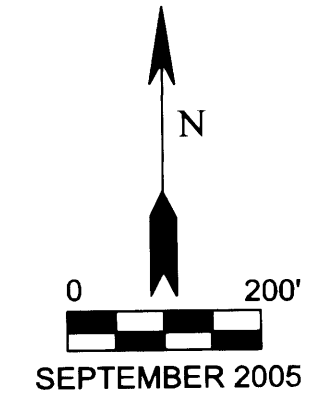


A PARTITION PLAT FOR SHAWN & TONYA STANDLEY

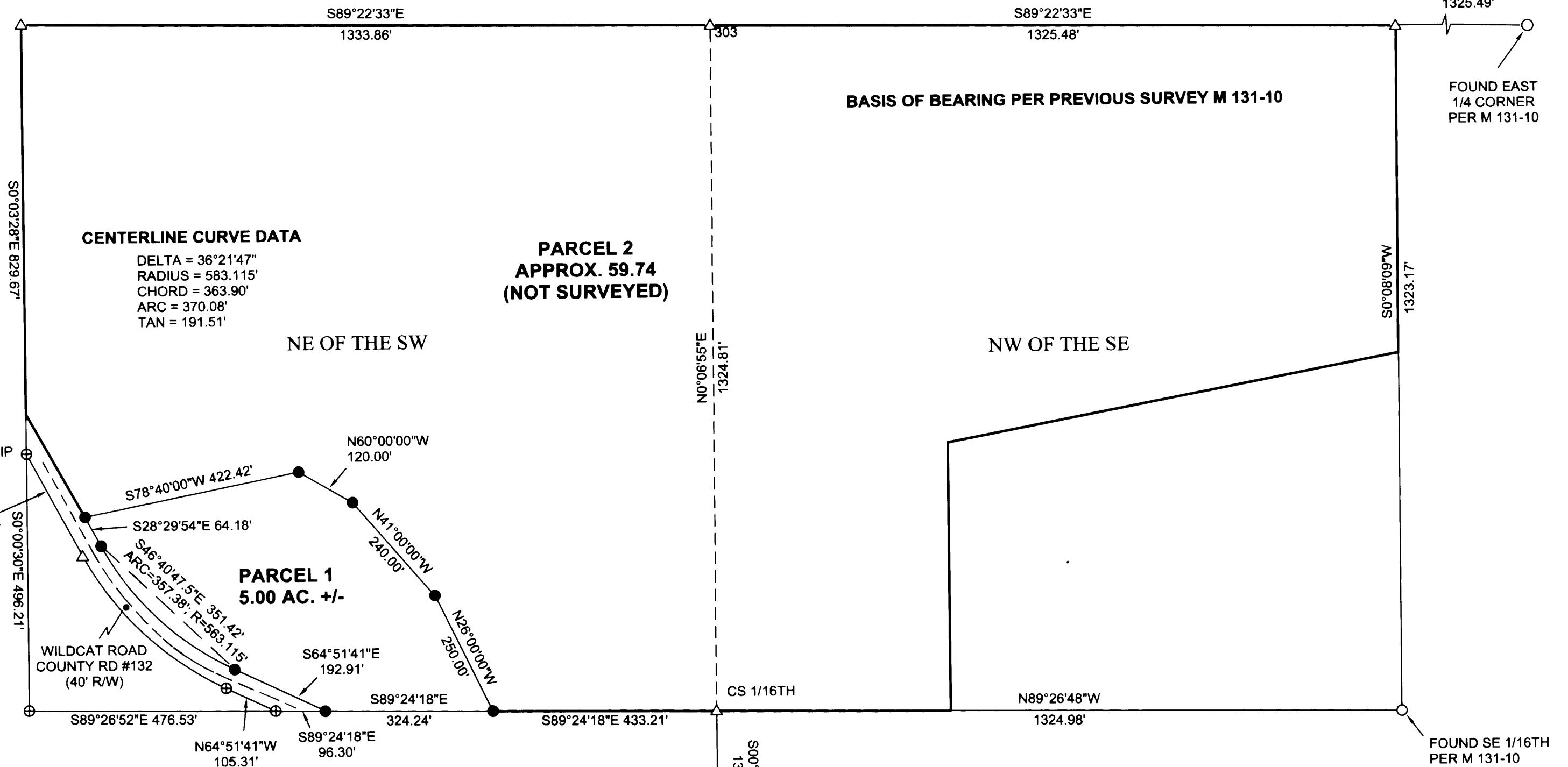

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO PARTITION 5 ACRES FROM THE STANDLEY PROPERTY AND LEAVE A REMAINDER OF APPROXIMATELY 59.74 ACRES.

THE SOUTH LINE OF THE 5 ACRE PROPERTY WAS LOCATED USING A FOUND MONUMENT PER M64-24 AND THE CS 1/16TH CORNER AS CALCULATED PER PREVIOUS CONTROL FROM M131-10. COUNTY ROAD #132 WAS MONUMENTED AT 40' FROM THE SOUTHERLY R/W AS PREVIOUSLY ESTABLISHED BY SURVEY M64-24. THE REMAINDER OF THE SET CORNERS WERE PLACED AS APPROVED BY THE OWNERS.
