

NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO PARTITION THE SUBJECT PROPERTY AS SHOWN. POINT "B" WAS CALCULATED AT RECORD DISTANCES FROM TWO FOUND BRASS CAPS PREVIOUSLY SET AS REFERENCE MONUMENTS. POINT "C" WAS CALCULATED ON LINE WITH POINTS "A" AND "B" AT RECORD DISTANCE FROM POINT "B" AS THE ERROR BETWEEN MEASURED AND RECORD DISTANCE IS SUSPECTED TO BE TO THE EAST OF POINT "C". THE GROUND BETWEEN POINTS "C" AND "A" IS FAIRLY STEEP. FOUND BENT 5/8" IRON ROD NEAR COMPUTED POINT "C" BUT USED COMPUTED POSITION SINCE ROD WAS SO BENT. COUNTY RIGHT-OF-WAY MAP FOR COUNTY RD. NO. 52, RECORDED AS 02460304, WAS COMPUTED FROM POINT "E" AND THEN ROTATED AROUND POINT "E". BETWEEN FOUND POINTS "E" AND "D". THESE FOUND MONUMENTS FIT RECORD DISTANCE EXACTLY. FOUND ALL MONUMENTS ON RIGHT-OF WAY BETWEEN POINTS "D" AND "E" AND ALL OF THESE MONUMENTS CLOSELY FIT RECORD LOCATIONS.

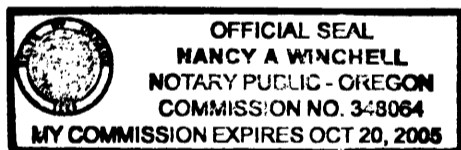
