

SURVEYOR'S CERTIFICATE:

I, RONALD A. QUIMBY, OREGON PROFESSIONAL LAND SURVEYOR NO. 1654, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION:

BEGINNING AT A 5/8-INCH IRON ROD AT THE SOUTHEAST CORNER OF THAT TRACT OF LAND AS DESCRIBED IN INSTRUMENT NUMBER 2006-007478, DOUGLAS COUNTY DEED RECORDS; THENCE ALONG THE SOUTH BOUNDARY OF SAID INSTRUMENT NUMBER 2006-007478, NORTH 88°06'43" WEST, 1483.87 FEET TO A 5/8-INCH IRON ROD AT THE SOUTHWEST CORNER OF SAID INSTRUMENT NUMBER 2006-007478; THENCE ALONG THE WEST BOUNDARY OF SAID INSTRUMENT NUMBER 2006-007478, NORTH 01°32'47" EAST, 552.02 FEET TO A POINT ON THE SOUTHERLY RIGHT-OF-WAY BOUNDARY OF STATE HIGHWAY NUMBER 42 FROM WHICH A 5/8-INCH IRON ROD BEARS NORTH 72°14'00", 6.00 FEET; THENCE ALONG SAID SOUTHERLY RIGHT-OF-WAY BOUNDARY, NORTH 72°14'00" EAST, 1572.36 FEET TO A 5/8-INCH IRON ROD AT THE INTERSECTION OF SAID SOUTHERLY RIGHT-OF-WAY BOUNDARY AND THE WEST RIGHT-OF-WAY BOUNDARY OF STRICKLAND CANYON ROAD (COUNTY ROAD NUMBER 108); THENCE ALONG SAID WEST RIGHT-OF-WAY BOUNDARY, SOUTH 01°32'53" EAST, 1080.90 FEET TO THE POINT OF BEGINNING.

SAID TRACT OF LAND CONTAINS 27.79 ACRES, MORE OR LESS.

NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO MONUMENT AND PARTITION THAT TRACT OF LAND AS DESCRIBED IN INSTRUMENT NUMBER 2006-007478, DOUGLAS COUNTY DEED RECORDS. THE PROCEDURE WAS AS FOLLOWS:

MONUMENTS OF RECORD WERE TIED AND HELD AS SHOWN. THE NORTH BOUNDARY LINE, ALSO BEING THE SOUTH RIGHT-OF-WAY BOUNDARY OF HIGHWAY NO. 42, WAS ESTABLISHED BY HOLDING THE FOUND MONUMENTS ALONG THE NORTH RIGHT-OF-WAY BOUNDARY AND OFFSETTING SAID NORTH RIGHT-OF-WAY BOUNDARY 60 FEET SOUTH. A 3/4-INCH BOLT AT THE NORTHWEST CORNER OF INSTRUMENT NUMBER 2001-12571, DOUGLAS COUNTY DEED RECORDS, WAS HELD AS BEING ON SAID SOUTH RIGHT-OF-WAY AND RECORD DISTANCES PER DOUGLAS COUNTY SURVEY M29-9 WERE USED TO ESTABLISH THE NORTHWEST AND NORTHEAST CORNERS OF SAID INSTRUMENT NUMBER 2006-007478. MONUMENTS WERE SET AS SHOWN HEREON. A CALCULATED POINT, "A", ON SAID NORTH BOUNDARY WAS ESTABLISHED BY INTERSECTING SAID NORTH BOUNDARY AT THE RECORD DISTANCE FROM SAID NORTHWEST CORNER AS SHOWN ON SAID SURVEY M29-9 WITH A LINE PRODUCED FROM THE FOUND 1/2-INCH PIPE, "B", AT THE SOUTHEAST CORNER OF PARCEL 2 OF INSTRUMENT NUMBER 72-16756, DOUGLAS COUNTY DEED RECORDS. THE WEST BOUNDARY WAS ESTABLISHED BY PROJECTING A LINE PARALLEL TO THE AFOREMENTIONED LINE BETWEEN POINTS "A" AND "B". THE SOUTH BOUNDARY WAS ESTABLISHED BY CALCULATING A POINT, "C", BY HOLDING THE RECORD DISTANCE FROM POINT "B" ALONG THE LINE BETWEEN "A" AND "B" AND ITS INTERSECTION WITH A PROJECTED LINE FROM THE 5/8-INCH IRON ROD AT THE SOUTHEAST CORNER OF SAID INSTRUMENT NUMBER 2006-007478 THROUGH POINT "C" TO ITS INTERSECTION WITH THE AFOREMENTIONED WEST BOUNDARY. A MONUMENT WAS SET AT SAID INTERSECTION POINT TO DELINEATE THE SOUTHWEST CORNER AS SHOWN HEREON. THE EAST BOUNDARY WAS ESTABLISHED BY PROJECTING A LINE BETWEEN SAID SOUTHEAST AND NORTHEAST CORNERS. MONUMENTS WERE SET IN ORDER TO DELINEATE THE PARCEL BOUNDARIES AS SHOWN.
