**NARRATIVE:**

THE PURPOSE OF THIS SURVEY WAS TO ADJUST THE BOUNDARY OF A PORTION OF THE PROPERTY AS SHOWN AND TO THEN PARTITION THE ADJUSTED UNIT 1 INTO THREE PARCELS AS SHOWN. THE CENTER 1/4 OF SECTION 17 WAS ALSO SET AND THE WESTERN BOUNDARY OF PARCEL 1 WAS MARKED FROM SAID C 1/4, SOUTHERLY TO THE 1/4 CORNER BETWEEN SECTION 17 AND 20. A ROD WHICH WAS SET FOR THE CS 1/16 CORNER OF 17 WAS TIED ALONG THE WAY. IT WAS FOUND TO BE ALMOST A FOOT OUT OF POSITION. A PIPE WAS FOUND AT THE NORTHEAST CORNER OF PARCEL 3, SAID PIPE BEING THE NNE CORNER OF D.L.C. NO. 38, BUT NO OTHER MONUMENTS OF THE NEIGHBORING SUBDIVISION WERE FOUND SO THE BEARING OF THE NORTHERN PROPERTY LINE WAS HELD TO ROUGHLY FOLLOW THE EXISTING FENCE. THE RESULTANT COMPUTED POINTS ON THIS LINE ARE APPROXIMATE CORNERS. FURTHER WORK WOULD BE REQUIRED TO CONFIRM THE TRUE LOCATION OF THIS LINE.
