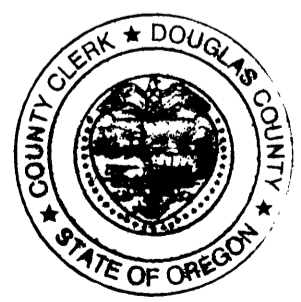

MONUMENTS "A" THROUGH "H" FOUND IN THE FIELD AND USED FOR CONTROL IN THIS SURVEY. THE NORTH BOUNDARY OF THE SUBJECT PROPERTY WAS ESTABLISH BY HOLDING LINE "D-E". THE EAST BOUNDARY WAS ESTABLISHED BY HOLDING MONUMENTS "A", "B" AND "C". THE NORTHEAST CORNER WAS ESTABLISH AT THE INTERSECTION OF SAID LINE "D-E" AND LINE "A-B-C". THE CENTERLINE OF HIGHWAY 99 WAS ESTABLISHED BY HOLDING 30.00 FEET WESTERLY FROM MONUMENTS "E", "F" AND "H".
