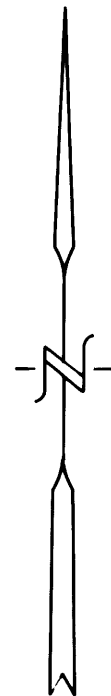

NARRATIVE:

PURPOSE OF THE SURVEY WAS TO CREATE THE PARCELS AS SHOWN. FIELD INVESTIGATION LOCATED THE SAID FOUND MONUMENTS AND CONDITIONS. THE EASTERLY BOUNDARY OF DONATION LAND CLAIM NUMBER 48, CONTROLLED THE BOUNDARY OF PARCEL 3 AND THE RE-TRACEMENT OF THE CENTER LINE OF HUNGRY U RANCH LANE PER SURVEY M 79-40, WAS USED TO CONTROL THE BOUNDARIES OF PARCEL 2. I OBTAINED THE COORDINATES FOR STATE PLANE FOR THE NORTHEAST AND SOUTHEAST CORNERS OF DONATION LAND CLAIM NUMBER 48, THEN USING A CONVERGENCE ANGLE OF - 1.8974523", CONVERTED THE GRID BEARING TO THE TRUE MEAN BEARING, WHICH I USED AS " BASIS OF BEARING ".
