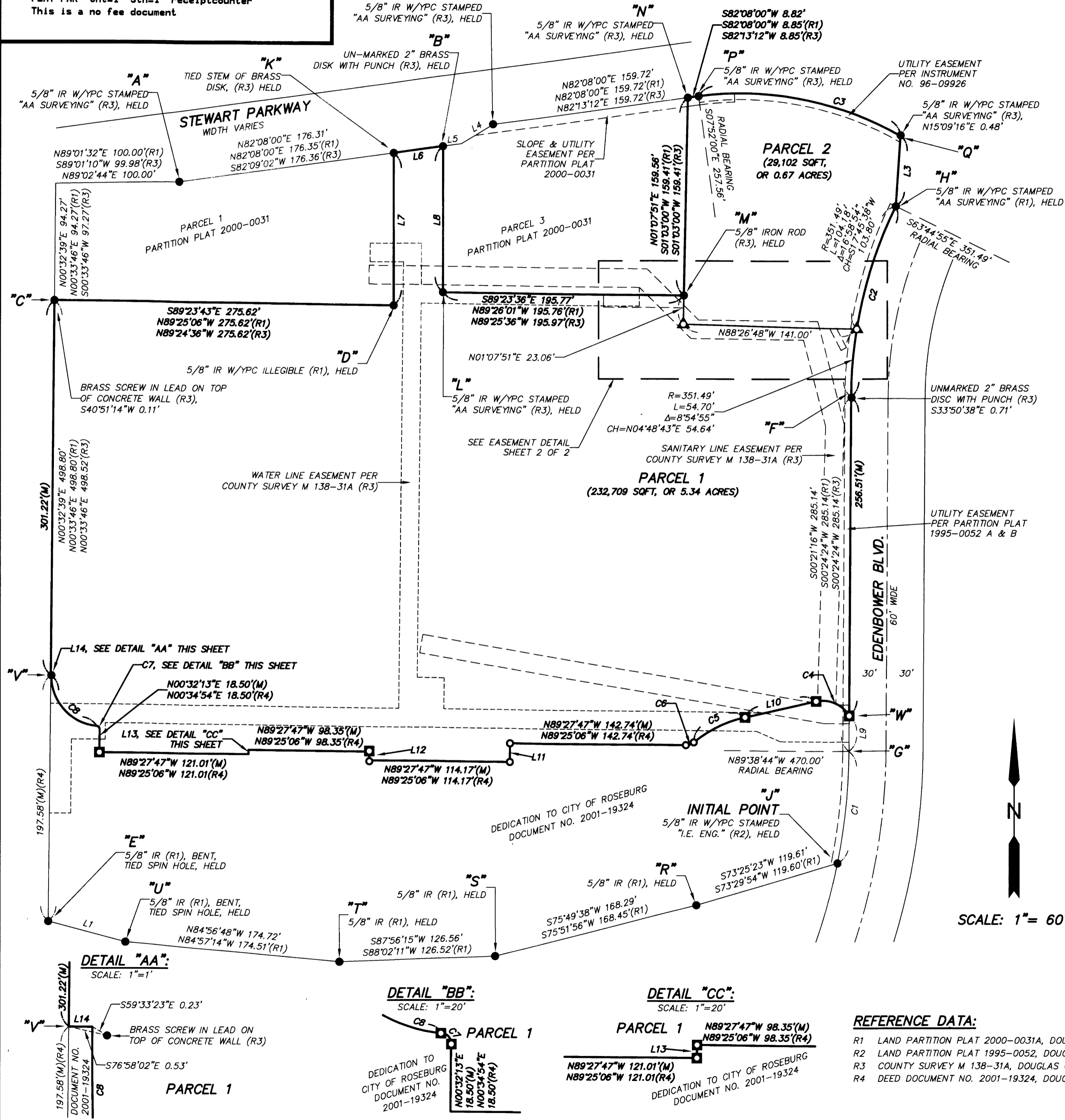

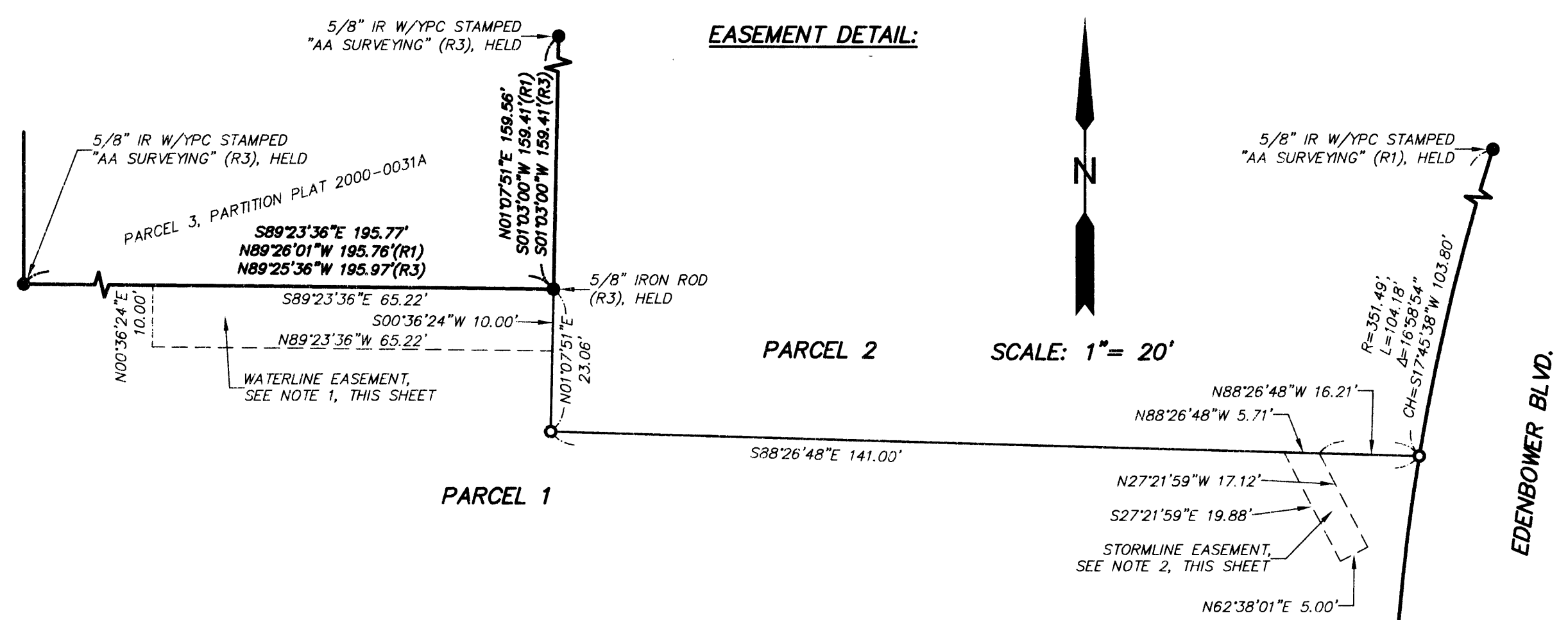

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO PARTITION A PORTION OF PARCEL 2 OF PARTITION PLAT NO. 2000-0031, DOUGLAS COUNTY PLAT RECORDS. THE BASIS OF BEARINGS FOR THIS SURVEY IS THE LINE REPRESENTED BY MONUMENTS FOUND AT POINT "A" AND POINT "B". I HAVE CALCULATED POINT "C" AT A PLAT (R1) DISTANCE OF 275.62 FEET FROM THE MONUMENT FOUND AT POINT "D" AND AT A PLAT (R1) DISTANCE OF 498.80 FEET FROM THE MONUMENT FOUND AT POINT "E".

I, THOMAS G. NELSON, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND REPRESENTED ON THE ATTACHED PARTITION MAP, BEING A PORTION OF PARCEL 2 OF PARTITION PLAT NO. 2000-0031, DOUGLAS COUNTY PLAT RECORDS, SITUATED IN THE NORTHWEST QUARTER OF SECTION 12, TOWNSHIP 27 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN, CITY OF ROSEBURG, DOUGLAS COUNTY, OREGON, SAID PARCEL BEING DESCRIBED AS FOLLOWS:

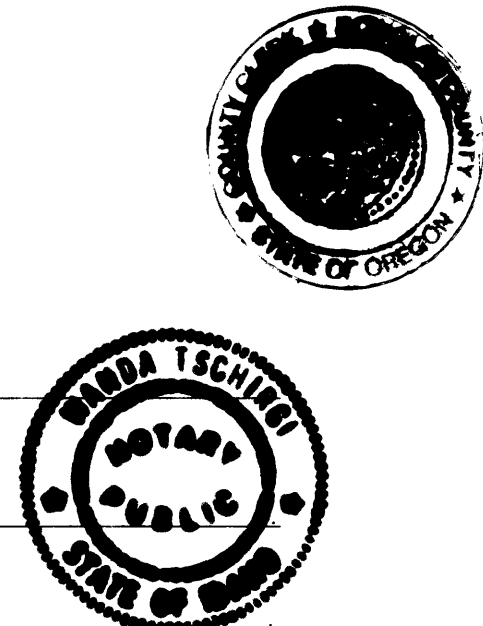
COMMENCING AT THE INITIAL POINT, BEING A 5/8 INCH IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "I.E. ENG." AT THE SOUTHEAST CORNER OF SAID PARCEL 2; THENCE, ALONG A 470.00 FOOT RADIUS CURVE TO THE LEFT ALONG THE EAST LINE OF SAID PARCEL 2, ALSO BEING THE WEST RIGHT-OF-WAY LINE OF EDENBOWER BLVD., A LENGTH OF 90.69 FEET THROUGH A CENTRAL ANGLE OF 110°3'21" TO A POINT OF TANGENCY, THE LONG CHORD OF WHICH BEARS NORTH 05°52'56" EAST A DISTANCE OF 90.55 FEET; THENCE, NORTH 00°21'16" EAST ALONG SAID EAST LINE OF SAID PARCEL 2, ALSO BEING SAID WEST RIGHT-OF-WAY LINE OF EDENBOWER BOULEVARD, A DISTANCE OF 28.63 FEET TO THE NORTHEAST CORNER OF THAT PORTION OF SAID PARCEL 2 DEDICATED TO THE CITY OF ROSEBURG IN DEED DOCUMENT NO. 2001-19324 AND THE POINT OF BEGINNING; THENCE, ALONG A NON-TANGENT 25.00 FOOT RADIUS CURVE TO THE LEFT ALONG THE NORTH LINE OF SAID DOCUMENT NO. 2001-19324 A LENGTH OF 31.22 FEET THROUGH A CENTRAL ANGLE OF 71°32'58", THE LONG CHORD OF WHICH BEARS NORTH 66°24'03" WEST A DISTANCE OF 29.23 FEET; THENCE, SOUTH 77°23'47" WEST ALONG SAID NORTH LINE A DISTANCE OF 59.29 FEET TO A POINT OF CURVATURE; THENCE, ALONG A 100.00 FOOT RADIUS CURVE TO THE LEFT ALONG SAID NORTH LINE A LENGTH OF 46.66 FEET THROUGH A CENTRAL ANGLE OF 26°44'08", THE LONG CHORD OF WHICH BEARS SOUTH 64°01'43" WEST A DISTANCE OF 46.24 FEET TO A POINT OF REVERSE CURVE; THENCE, ALONG A 10.00 FOOT RADIUS CURVE TO THE RIGHT ALONG SAID NORTH LINE A LENGTH OF 6.96 FEET THROUGH A CENTRAL ANGLE OF 39°52'32", THE LONG CHORD OF WHICH BEARS SOUTH 70°35'56" WEST A DISTANCE OF 6.82 FEET;
