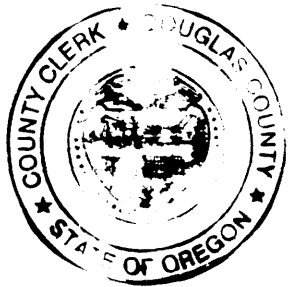

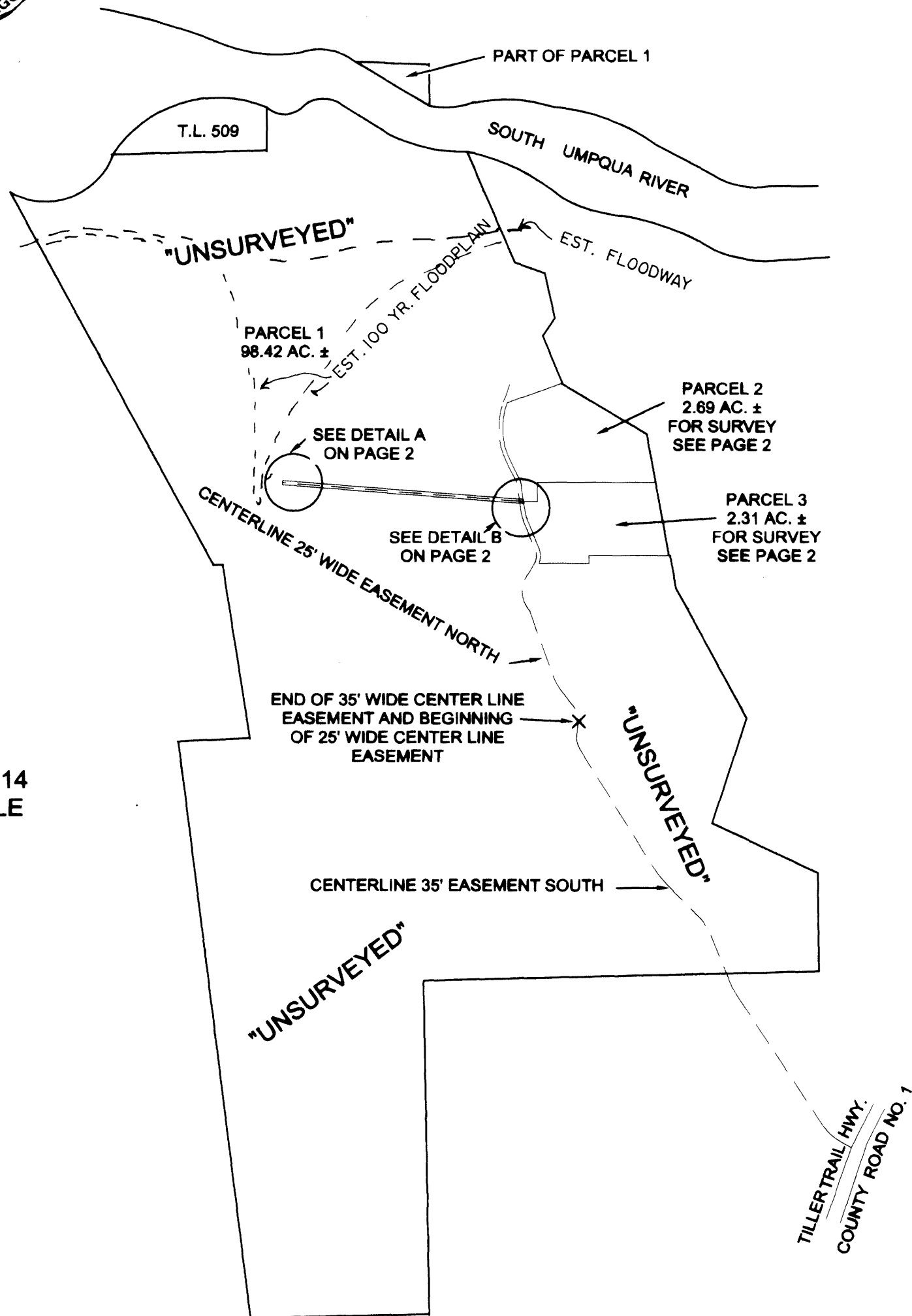

35 FOOT WIDE ROAD AND UTILITY EASEMENT:

THE FOLLOWING DESCRIBED CENTER LINE DESCRIPTION IS LOCATED IN THE EAST HALF OF SECTION 27 AND IN THE SOUTHWEST QUARTER OF SECTION 26, TOWNSHIP 30 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY.
BEGINNING AT A POINT LOCATED ON THE WESTERLY RIGHT OF WAY OF STATE HIGHWAY NUMBER 227 (ALSO KNOWN AS DOUGLAS COUNTY ROAD NUMBER 1), SAID POINT BEARS SOUTH 1°18'43" WEST 3233.14 FEET FROM THE SECTION CORNER COMMON TO SECTIONS 22, 23, 26 AND 27, TOWNSHIP 30 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON; THENCE ALONG THE CENTER LINE OF AN EXISTING ROAD, NORTH 61°10'53" WEST 44.55 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE, ALONG THE ARC OF A 126.19 FOOT RADIUS TO THE RIGHT, THE LONG CHORD OF WHICH BEARS NORTH 48°20'40" WEST 63.85 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE, NORTH 33°41'20" WEST 501.11 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE ALONG THE ARC OF A 301.83 FOOT RADIUS CURVE TO THE RIGHT, THE LONG CHORD OF WHICH BEARS NORTH 27°49'29" WEST 61.68 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE, NORTH 21°57'38" WEST 142.78 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE, ALONG THE ARC OF A 195.19 FOOT RADIUS CURVE TO THE LEFT, THE LONG CHORD OF WHICH BEARS NORTH 33°08'37" WEST 75.67 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE, NORTH 44°19'36" WEST 147.59 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE; ALONG THE ARC OF A 356.83 FOOT RADIUS CURVE TO THE RIGHT, THE LONG CHORD OF WHICH BEARS NORTH 38°06'54" WEST 77.22 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE, NORTH 31°54'12" WEST 435.82 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE, ALONG THE ARC OF A 64.77 FOOT RADIUS CURVE TO THE RIGHT, THE LONG CHORD OF WHICH BEARS NORTH 12°47'06" WEST 42.42 FEET TO A POINT; THENCE CONTINUING ALONG SAID CENTER LINE, NORTH 6°19'59" EAST 35.95 FEET TO A POINT LOCATED AT THE BEGINNING OF A 25 FOOT WIDE CENTER LINE ALONG SAID EXISTING ROAD AND THERE TERMINATES. 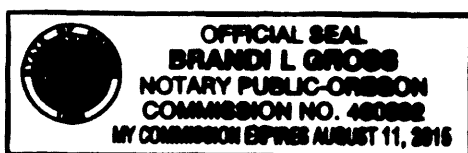
