I, F. NEIL HIBBS, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THE ANNEXED PLAT, OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION. PARCEL 1 BEING UNSURVEYED.

THAT LAND DESCRIBED IN INSTRUMENT NO. 96-23177 OF THE DEED RECORDS OF DOUGLAS COUNTY, OREGON.

AND PER INST. NO. 2014-015354, LESS ANY PORTION OF DLC NO. 40 THAT MAY LIE NORTH OF THE FENCE LINE AGREED TO AND TOGETHER WITH ANY PORTION OF DLC NO. 50 THAT MAY LIE SOUTH OF THE FENCE LINE AGREED TO.

**NARRATIVE:**

THE PURPOSE OF THIS SURVEY WAS TO PARTITION THE SUBJECT PROPERTY INTO THREE PARCELS, TOGETHER WITH EASEMENTS, AS SHOWN. MONUMENTATION IS VERY SCARCE IN THIS AREA, BOTH IN REGARDS TO THE SECTION ITSELF AS WELL AS THE DONATION LAND CLAIMS COMING TOGETHER NEAR THE NORTHWEST CORNER OF THE SUBJECT PROPERTY. BASED ON OLD VOLUME 1, PAGE 175 OF THE DOUGLAS COUNTY SURVEY RECORDS, THE NORTHWEST CORNER OF THE PATTERSON DLC NO. 40 WAS 2.53 CHAINS EAST OF THE CENTER SECTION LINE. THIS DISTANCE IS ALSO NOTED DIRECTLY ON THE 1863 DLC PLAT. THE COUNTY RIGHT-OF-WAY ON COUNTY ROAD NO. 128 WAS CALCULATED PER SHEET 2 OF 6 OF THE 1966 COUNTY ROAD PLANS, THIS SHEET ON LINE AS 02300231. THIS CALCULATED RIGHT-OF-WAY WAS BROUGHT TOGETHER WITH THE TIED MONUMENT AT "A", THIS ROD BEING 35 FEET LEFT OF STATION NO. 26+00. THE CALCULATED RIGHT-OF-WAY WAS THEN ROTATED AROUND "A" TO BRING INTO ALIGNMENT WITH LINE BETWEEN FOUND MONUMENTS "A" AND "B". A GOOD NUMBER OF RIGHT-OF-WAY MONUMENTS ARE MISSING BUT THE ONES THAT ARE LEFT FIT PRETTY WELL. WITH ALL OF THE PROBLEMS IN THE AREA WITH MISSING MONUMENTATION, A BOUNDARY LINE AGREEMENT AND CONVEYANCE WAS FILED BETWEEN THE LANEYS AND GLADYS MILTON WHICH WAS RECORDED AS INSTRUMENT NO. 2014-015354. WITH THIS AGREEMENT IN PLACE, MONUMENTS ALONG THE NORTHERN BOUNDARY OF THE SUBJECT PROPERTY WERE SET IN THE EXISTING FENCE. AS SHOWN IN DETAIL, AFTER CALCULATING POINT "E" AT RECORD DISTANCE FROM POINT "D", LINE "E-C" FITS THE ORIGINAL 1855 GLO DISTANCE FAIRLY WELL. ESPECIALLY CONSIDERING THAT THE ACTUAL CORNER HAS BEEN LOST AND RE-ESTABLISHED SO MANY TIMES. AT POINT "C", BYRON'S 12" OAK BT IS NOW A STUMP AND APPROX. 26" DIAMETER. BYRON'S 20" OAK IS STANDING, NOW APPROX 36". DID NOT OPEN EITHER BUT THEY FIT LOCATION OF FOUND STONE.
