THE ROD SET TO THE WEST OF THIS POINT WAS SET ON AN EXTENSION OF THE BETWEEN THE FOUND AND COMPUTED POINTS EAST OF IT.

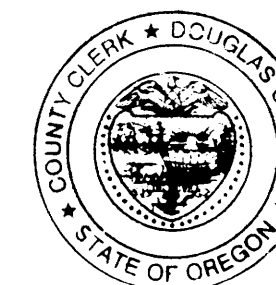
