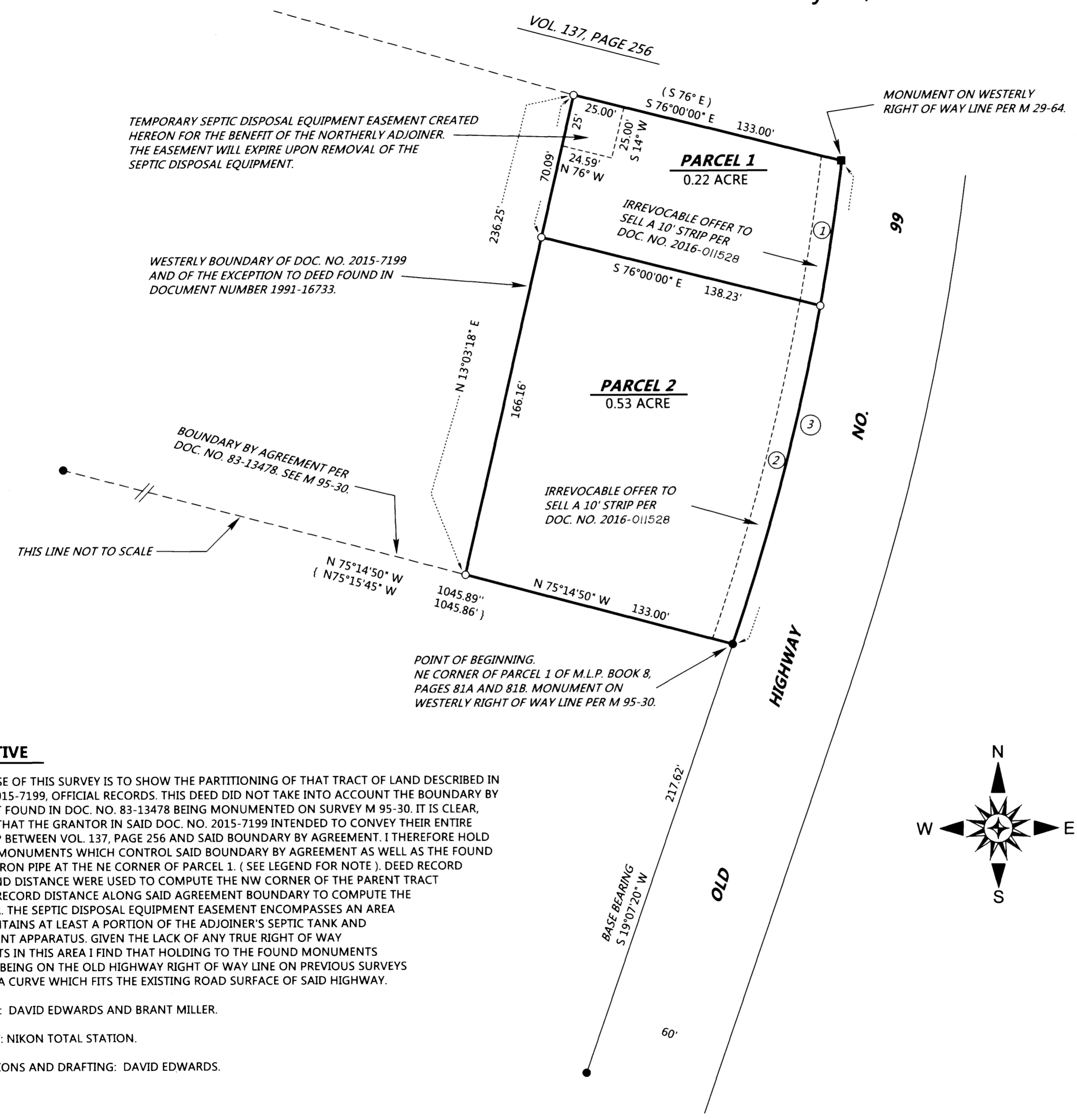

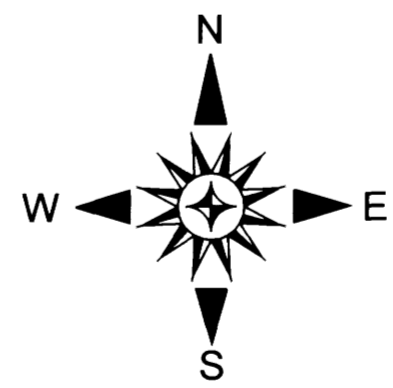

### NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO SHOW THE PARTITIONING OF THAT TRACT OF LAND DESCRIBED IN DOC. NO. 2015-7199, OFFICIAL RECORDS. THIS DEED DID NOT TAKE INTO ACCOUNT THE BOUNDARY BY AGREEMENT FOUND IN DOC. NO. 83-13478 BEING MONUMENTED ON SURVEY M 95-30. IT IS CLEAR, HOWEVER, THAT THE GRANTOR IN SAID DOC. NO. 2015-7199 INTENDED TO CONVEY THEIR ENTIRE OWNERSHIP BETWEEN VOL. 137, PAGE 256 AND SAID BOUNDARY BY AGREEMENT. I THEREFORE HOLD TO FOUND MONUMENTS WHICH CONTROL SAID BOUNDARY BY AGREEMENT AS WELL AS THE FOUND 1/2" DIAM. IRON PIPE AT THE NE CORNER OF PARCEL 1. (SEE LEGEND FOR NOTE). DEED RECORD BEARING AND DISTANCE WERE USED TO COMPUTE THE NW CORNER OF THE PARENT TRACT AND DEED RECORD DISTANCE ALONG SAID AGREEMENT BOUNDARY TO COMPUTE THE SW CORNER. THE SEPTIC DISPOSAL EQUIPMENT EASEMENT ENCOMPASSES AN AREA WHICH CONTAINS AT LEAST A PORTION OF THE ADJOINER'S SEPTIC TANK AND APPURTENANT APPARATUS. GIVEN THE LACK OF ANY TRUE RIGHT OF WAY MONUMENTS IN THIS AREA I FIND THAT HOLDING TO THE FOUND MONUMENTS SHOWN AS BEING ON THE OLD HIGHWAY RIGHT OF WAY LINE ON PREVIOUS SURVEYS PRODUCES A CURVE WHICH FITS THE EXISTING ROAD SURFACE OF SAID HIGHWAY.
