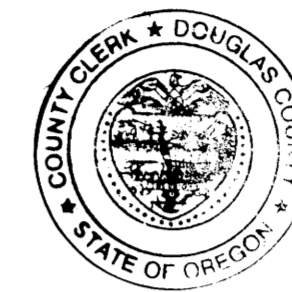

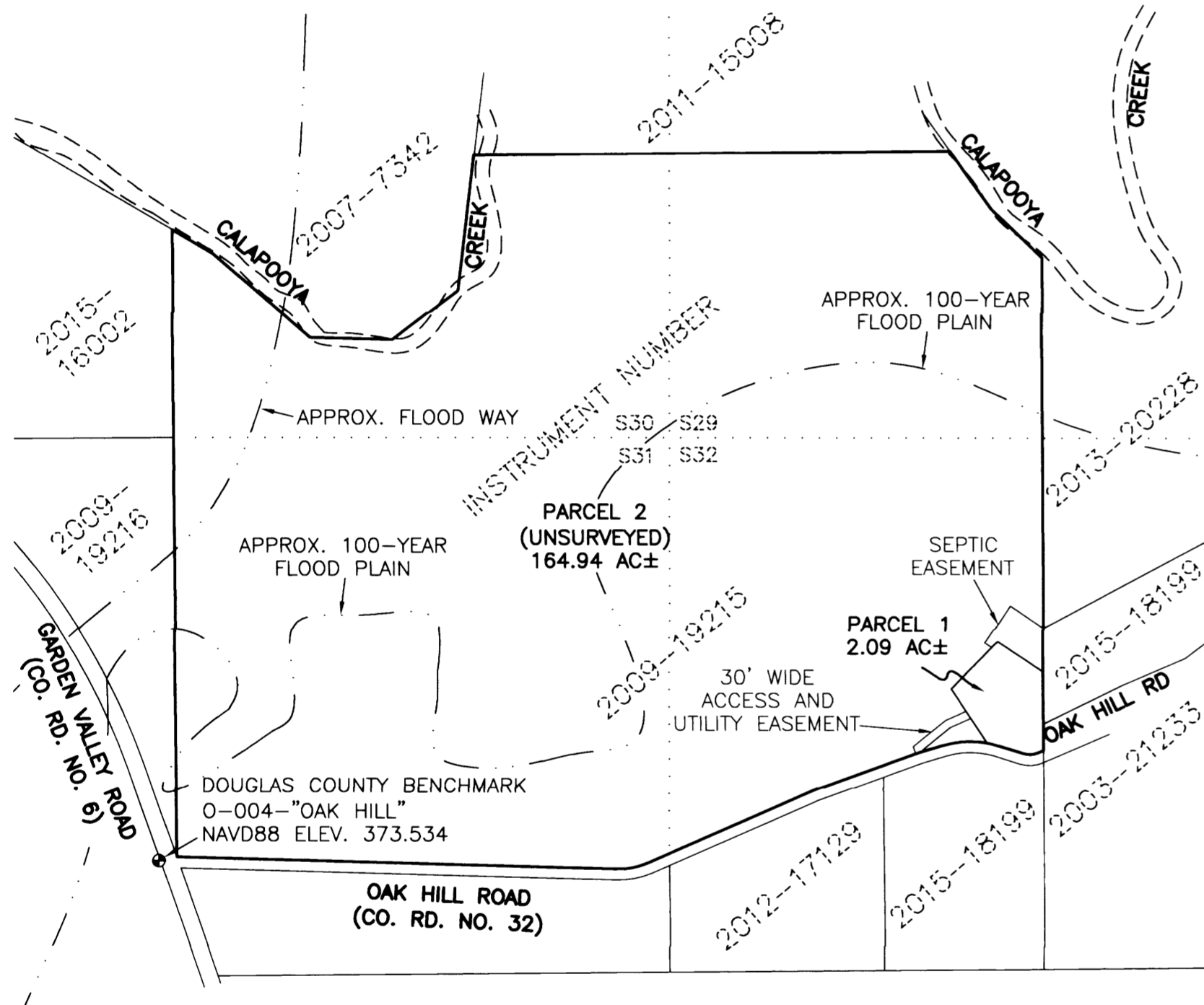
NARRATIVE:

THE PURPOSE OF THIS MAP IS TO PARTITION THAT TRACT OF LAND DESCRIBED IN INSTRUMENT NUMBER 2009-19215, DEED RECORDS OF DOUGLAS COUNTY, OREGON. THE PROCEDURE WAS AS FOLLOWS:

MONUMENTS OF RECORD WERE FOUND AND HELD AS SHOWN. THE EAST BOUNDARY WAS ESTABLISHED BETWEEN THE SOUTHEAST CORNER OF DLC 41 AND THE NORTHWEST CORNER OF THAT TRACT SHOWN ON DOUGLAS COUNTY SURVEY M73-80. THE SOUTH RIGHT-OF-WAY BOUNDARY OF OAK HILL ROAD (DOUGLAS COUNTY ROAD NUMBER 32) WAS ESTABLISHED BY HOLDING THE FOUND MONUMENTS PER SURVEY NUMBER M33-28. THE RIGHT-OF-WAY BOUNDARY WAS OFFSET 40.00 FEET NORTH TO ESTABLISH THE SOUTH BOUNDARY OF PARCEL 2 AND A PORTION OF THE SOUTH BOUNDARY OF THE UNSURVEYED PARCEL 1. THE CENTERLINE OF THE PAVED ROAD WAS ALSO TIED AND FITS THE ESTABLISHED BOUNDARY PER M33-28. MONUMENTS WERE SET AT ON THE NORTH RIGHT-OF-WAY BOUNDARY AND AT THE CORNERS OF PARCEL 2 AS SHOWN. THIS SURVEY WAS PERFORMED BY JEREMY LEONARD AND NOLAN FROMDAHL USING A TOPCON TOTAL STATION AND TOPCON FC-5000 CONTROLLER. OFFICE CALCULATIONS AND DRAFTING BY BRENT KNAPP.

OVERALL SCHEMATIC

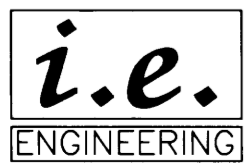

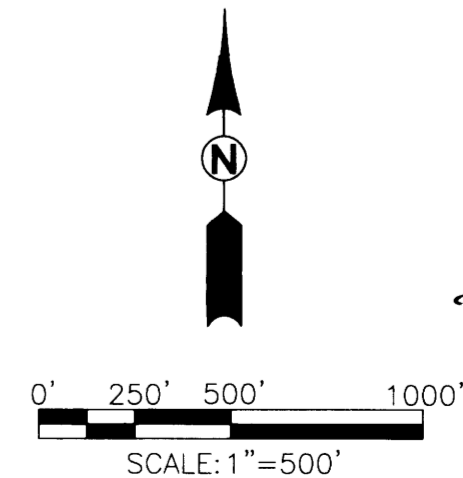
