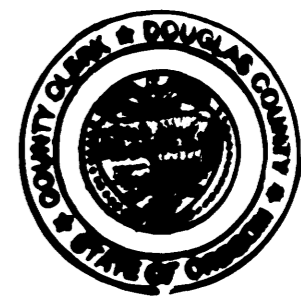

SET RODS BETWEEN FOUND MONUMENTS AS SHOWN. WATERLINE EASEMENT REFERENCED IN THE DEED IS NOT PLOTTABLE AS THERE IS NO DESCRIPTION. INSTRUMENT NO. 66-12748 CALLS IT AS BEING 20 FEET WIDE AND NOTES THAT A SUBSEQUENT SURVEY WAS TO BE PERFORMED AFTER THE COMPLETION OF THE PIPE LINE TO SHOW THE EXACT LOCATION.
