I, RONALD A. QIMBY, OREGON PROFESSIONAL LAND SURVEYOR NO. 1654, HEREBY CERTIFY THAT PARCEL 2 IS UN-SURVEYED AND THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS PARCEL 1 SHOWN ON THE ANNEXED PLAT, OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION.

NARRATIVE:

THE PURPOSE OF THIS MAP IS TO PARTITION THE ABOVE-DESCRIBED TRACT INTO 2 PARCELS AS SHOWN UNDER THE PROVISIONS OF SECTION 3.5.200.1b(6) OF THE DOUGLAS COUNTY LAND USE AND DEVELOPMENT ORDINANCE. MONUMENTS OF RECORD PER M146-2 WERE TIED AND HELD AS SHOWN. MONUMENTS WERE THEN SET TO DELINEATE PARCEL 1 AS SHOWN. THIS SURVEY WAS PERFORMED BY JEREMY LEONARD AND DAWSON JINKINS USING A TOPCON TOPCON TOTAL STATION AND TOPCON GPS AND DATA COLLECTION EQUIPMENT. OFFICE CALCULATIONS AND DRAFTING WERE PERFORMED BY DEREK FEIGEL.

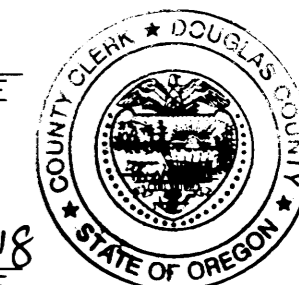
