NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO PARTITION THE SUBJECT PROPERTY INTO 2 PARCELS AS SHOWN. POINT "C" WAS CALCULATED AT DISTANCE-DISTANCE INTERSECTION FROM FOUND MONUMENTS AT POINTS "A" AND "D" PER LAND PARTITION 2006-0082. POINT "E" WAS SET AT MID-POINT BETWEEN POINTS "A" AND "C". BECAUSE OF SLIGHT FENCE ENCROACHMENT ALONG SOUTHERN BOUNDARY, HAD TO SET A REFERENCE MONUMENT 1.00 FEET NORTHERLY OF ACTUAL COMMON CORNER BETWEEN PARCELS 1 AND 2. ALSO SLIGHT FENCE ENCROACHMENT ON NORTHERN END BUT TALKED WITH THAT NEIGHBOR AND THEY WERE FINE WITH SETTING ROD ON THEIR SIDE OF THE EXISTING FENCE.
