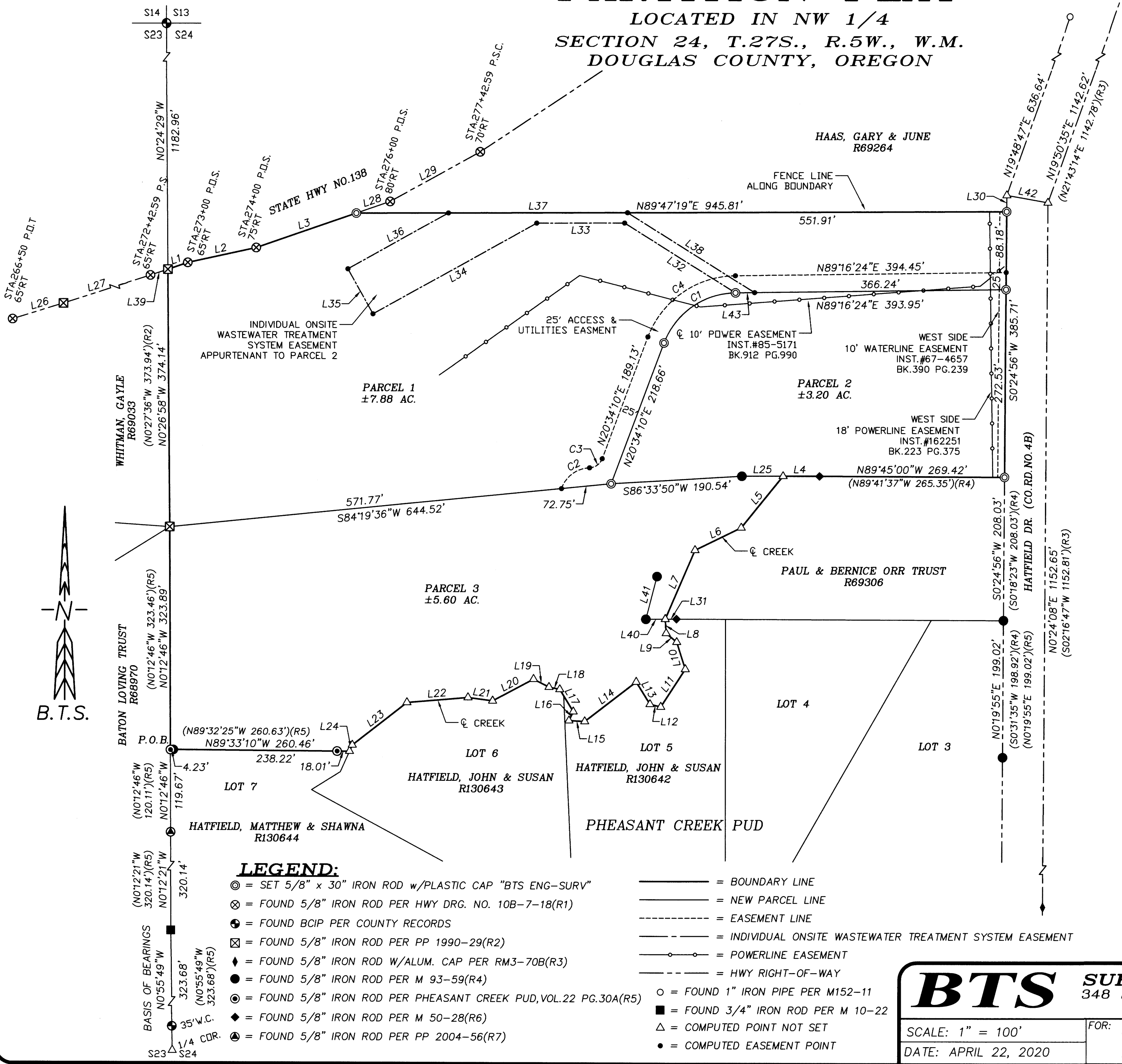


# PARTITION PLAT

DOUGLAS COUNTY, OREGON



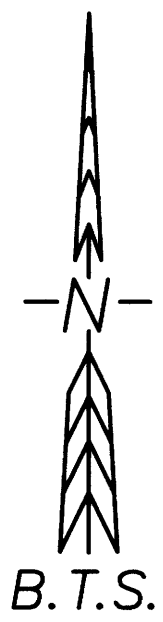
