




MONUMENTS FOUND PER LAND PARTITION 2006-0035, DUNCAN'S FIRST ADDITION TO YONCALLA AND DUNCAN'S YONCALLA NORTH WERE TIED AND HELD AS SHOWN. POINT "C" WAS SET ON LINE "A-D". POINT "D" TO THE FOUND 2 1/2" IRON PIPE INITIAL POINT OF DUNCAN'S FIRST ADDITION TO YONCALLA BEARS S 87°16'56" E 730.24 FEET, 2006-0035 RECORD FOR THIS LINE IS S 89°05'05" E 730.58 FEET. LAND PARTITION 2006-0035 DOES NOT SHOW ANY OF THE OTHER MONUMENTS FOUND PER DUNCAN'S FIRST ADDITION. POINT "G" WAS SET A PROPORTIONED DISTANCE-DISTANCE INTERSECTION FROM POINTS "E" AND "F".
