DECLARATION:

KNOW ALL PEOPLE BY THESE PRESENT THAT WEEKLY HOLDINGS, LLC IS THE OWNER OF THE LAND REPRESENTED ON THIS LAND PARTITION PLAT AND MORE PARTICULARLY DESCRIBED IN THE ACCOMPANYING SURVEYOR'S CERTIFICATE AND IN ACCORDANCE WITH THE PROVISIONS OF CHAPTER 92, OREGON REVISED STATUTES, HAS CAUSED THE SAME TO BE SURVEYED AND PARTITIONED AS SHOWN ON THE FACE OF THIS LAND PARTITION PLAT.

NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO PARTITION PARCEL 1 OF LAND PARTITION NO. 2005-0047 INTO 2 PARCELS AS APPROVED UNDER DOUGLAS COUNTY PLANNING DEPARTMENT FILE NO. 21-043. THE SURVEY WAS CONTROLLED BY MONUMENTS FOUND PER PARTITION PLAT 2005-0047. NEW MONUMENTS WERE SET AS DIRECTED BY THE OWNER.

THE SECTION CORNER COMMON TO SECTIONS 19, 20, 29, & 30 WAS NOT FOUND BUT THE REFERENCES DESCRIBED ON SAID PLAT WERE FOUND. A COMPUTED POINT USING JUST THE DISTANCES FROM THE IRON ROD REFERENCES DID NOT AGREE WITH RECORD DISTANCES TO THE 1/4 CORNER FOR SECTIONS 29 & 30 OR THE NORTHEAST CORNER OF PARCEL 1, ±2 FEET. INSTEAD I COMPUTED A COORDINATE USING RECORD DISTANCES FROM THE 1/4 CORNER AND THE NORTHEAST CORNER OF PARCEL 1. I THEN PROJECTED A LINE FROM THE IRON ROD REFERENCE SOUTHEAST OF THE SECTION CORNER THROUGH SAID COORDINATE THE RECORD DISTANCE FROM THE REFERENCE TO DEFINE THE LOCATION OF THE SECTION CORNER. THIS AGREES WITH THE RECORD DISTANCES EXCEPT FOR THE REFERENCE TO THE NORTHWEST WHICH IS NOW 16.89' (17.15'). AT THE DEFINED LOCATION I HAVE SET A 5/8"X30" IRON ROD WITH AN 2" ALUMINUM CAP PROPERLY MARKED.

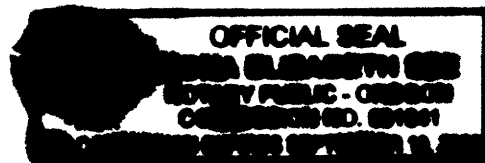
