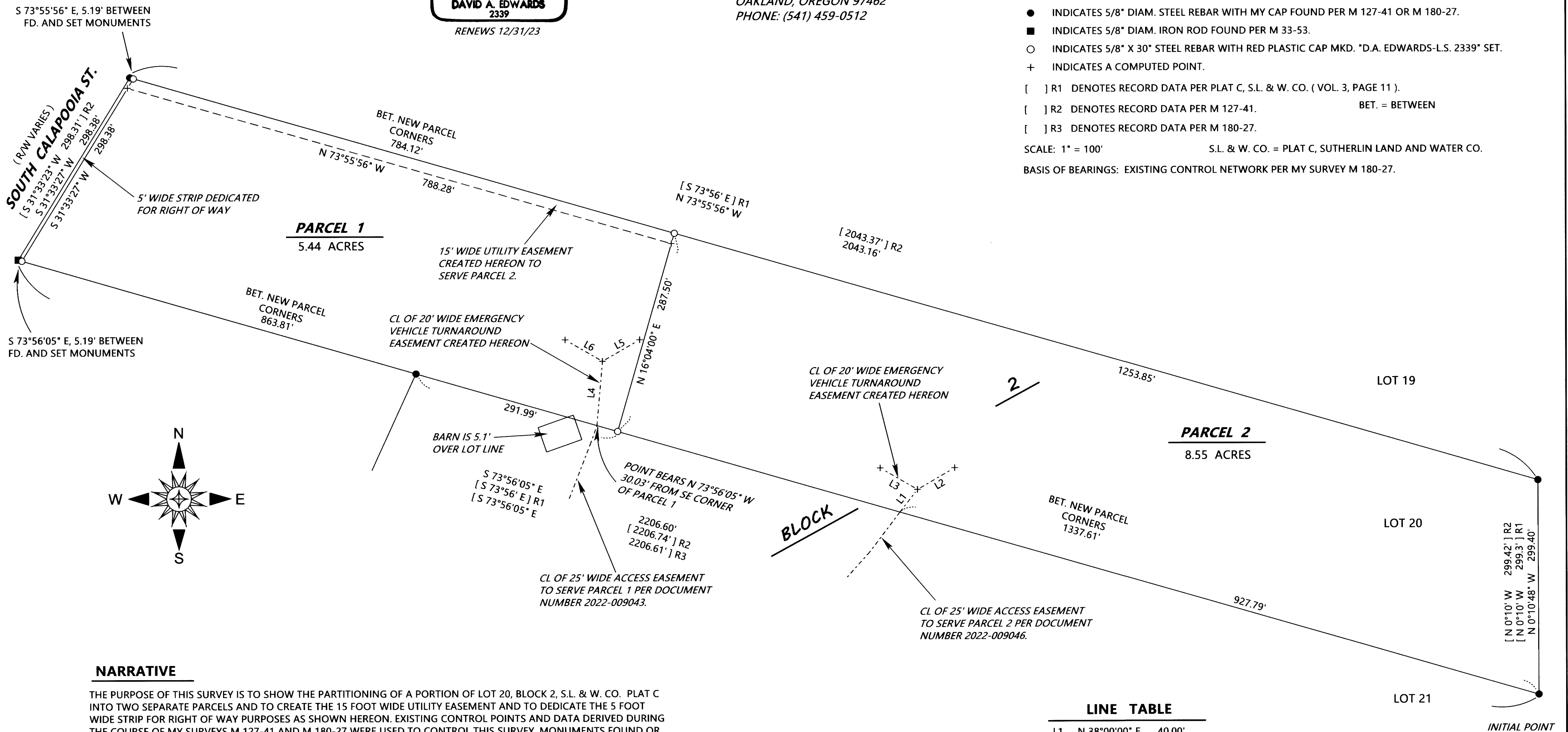

### NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO SHOW THE PARTITIONING OF A PORTION OF LOT 20, BLOCK 2, S.L. & W. CO. PLAT C INTO TWO SEPARATE PARCELS AND TO CREATE THE 15 FOOT WIDE UTILITY EASEMENT AND TO DEDICATE THE 5 FOOT WIDE STRIP FOR RIGHT OF WAY PURPOSES AS SHOWN HEREON. EXISTING CONTROL POINTS AND DATA DERIVED DURING THE COURSE OF MY SURVEYS M 127-41 AND M 180-27 WERE USED TO CONTROL THIS SURVEY. MONUMENTS FOUND OR SET ON THOSE TWO SURVEYS WERE NOT RETIED FOR THIS SURVEY.
