### NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO LOCATE AND MONUMENT THE NEW BOUNDARY BETWEEN PARCEL 1 AND PARCEL 2 AND TO MARK THE SOUTH BOUNDARY OF PARCEL 1 AND A PORTION OF THE NORTH BOUNDARY OF PARCEL 1. CONTROLLING MONUMENTS WERE TIED IN AS SHOWN ON SHEET TWO WITH THE BASIS OF BEARINGS BEING PARTITION PLAT NUMBER 2010-0031. RECORD DATA PER THAT SURVEY WAS USED TO COMPUTE PORTIONS OF THE PARCEL BOUNDARIES AS SHOWN ON SAID SHEET TWO. MY MEASUREMENTS AND THOSE FROM SAID PARTITION PLAT MATCH QUITE CLOSELY. THE NEW BOUNDARY BETWEEN PARCEL 1 AND PARCEL 2 AND THE SOUTH LINE OF PARCEL 1 WERE BLAZED, POSTED WITH STEEL POSTS AND FLAGGED WITH RED AND BLUE FLAGGING. BEARING TREES WERE SCRIBED "PC BT" UNLESS NOTED OTHERWISE AND ARE SITUATED AS NOTED ON SHEET TWO.

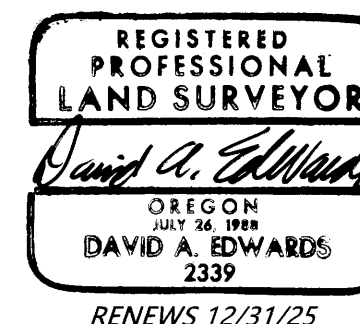
