SURVEY DATUM- PER OAR 734-005-015 OREGON COORDINATE REFERENCE SYSTEM (OCRS):

 NAD83(2011) EPOCH 2010 (INTERNATIONAL FEET)

EQUIPMENT- THE FIELD WORK FOR THIS PROJECT WAS INITIATED IN NOVEMBER OF 2020 AND CARRIED ON INTERMITTENTLY THROUGH NOVEMBER OF 2022. 2 LEICA GS14 GNSS RECEIVERS, 2 LEICA CS20 DATA COLLECTORS, AND 1 LEICA TS16 TOTAL STATION WERE UTILIZED TO PERFORM THE FIELD WORK.

CONTROL NARRATIVE AND BASIS OF BEARINGS

ALL BEARINGS FOR THIS SURVEY ARE BASED ON THE OREGON COORDINATE REFERENCE SYSTEM (OCRS), COTTAGE GROVE - CANYONVILLE ZONE, NAD 83(2011) EPOCH 2010.00. ALL COORDINATES ARE IN INTERNATIONAL FEET UNITS.

FOUND NETWORK POINTS AND FOUND MONUMENTATION SHOWN HEREON WERE MEASURED UTILIZING A MINIMUM OF 2 REDUNDANT 60 EPOCH GNSS OBSERVATIONS WHILE CONNECTED TO THE ORGN IN ACCORDANCE WITH ODOT'S SURVEY POLICY AND PROCEDURES MANUAL. IN THE EVENT THAT THE SKY WAS OBSTRUCTED AND A GNSS MEASUREMENT COULD NOT BE PERFORMED, ADDITIONAL CONTROL WAS SET UTILIZING THE ORGN. A TOTAL STATION WAS THEN UTILIZED TO TIE THE MONUMENT IN ACCORDANCE WITH ODOT'S POLICY AND PROCEDURE'S MANUAL.

CONTROL POINTS FOR THIS SURVEY WERE NOT SET ON AND DO NOT REPRESENT PROPERTY OR RIGHT OF WAY LINES AND ARE INTENDED FOR THE USE BY ODOT IN SUPPORT OF THIS AND FUTURE PROJECTS. IT IS NOT THE INTENT OF ODOT TO PERPETUATE THESE CONTROL POINTS AS MONUMENTS.

SURVEY NARRATIVE

THIS SURVEY WAS MADE AS A RESULT OF THE OREGON DEPARTMENT OF TRANSPORTATION'S I-5: EXIT 125 NORTHBOUND AT GARDEN VALLEY BLVD PROJECT. THE PURPOSE OF THIS SURVEY IS TO RECORD THE POSITIONS OF CONTROL POINTS AND THE MONUMENTS OF RECORD, RESOLVE THE EXISTING RIGHT OF WAY (R/W) CENTERLINE, AND DEFINE THE EXISTING RIGHT OF WAY LINES AS DIRECTED IN OREGON REVISED STATUTE (ORS)209.155. SURVEY WORK FOR THIS PROJECT WAS PERFORMED BY ODOT SURVEY CREWS BETWEEN NOVEMBER 2020 TO NOVEMBER 2022.

THE SCOPE OF THIS PROJECT IS FOR PROPOSED ADA UPGRADES, SIGNAL AND SIGNING UPGRADES AND ADDING A DESIGNATED RIGHT TURNING LANE TO THE NORTHBOUND OFFRAMP ONTO GARDEN VALLEY BLVD. ORIGINALLY ODOT HAD IMPROVEMENT PROJECTS IN THIS SAME AREA. SURVEYS AND ACQUISITIONS TOOK PLACE AS EVIDENCED BY ODOT MAP NOS. 7B-7-11 AND 2L-48 AND CORRESPONDING HORIZONTAL CONTROL AND RECOVERY SURVEY FILED AS ST.HWY. 15-006 IN THE DOUGLAS COUNTY SURVEYORS OFFICE.

PER FILED SURVEY ST. HWY. 15-006, FOUND CONTROL MONUMENT NUMBERS 46; 523; 524 AND "I-DID" AS WELL AS FOUND MONUMENT NUMBERS 1029 (#1067 FROM SAID SURVEY) AND 1032 ("NWDLC56" FROM SAID SURVEY) WERE RECOVERED AND TIED WITH 2 INDEPENDENT 60 SECOND ORGN OBSERVATIONS SEPARATED BY A MINIMUM OF 30 MINUTES. THIS ESTABLISHED A METHOD FOR MOVING THE OLD SURVEY DATA OVER ONTO THE CURRENT OCRS COORDINATE SYSTEM VALUES. THE NEW TIES FIT THE RELATIVE RECORD VALUES OF THE CONTROL AND MONUMENTS WELL, WITH THE EXCEPTION OF POINT NUMBER 46. POINT NUMBER 46 APPEARS TO HAVE BEEN DISTURBED SO THE NEW TIE VALUES WERE HELD. ALL FOUND OR SET MONUMENTS PER SAID SURVEY NOW HAVE NEW COORDINATE VALUES AND IF DISTURBED CAN BE RESET IN THEIR ORIGINAL LOCATIONS BASED ON THIS SURVEY.

"GV" & "GV1" CENTER LINE RIGHT OF WAY RESOLUTION:
 THE RECORD ALIGNMENT OF RIGHT OF WAY DRAWINGS 7B-7-11 AND 2L-48 (BOTH DRAWINGS REFERENCE THE SAME ALIGNMENT FOR GARDEN VALLEY) WAS DRAWN IN AND THEN PLACED BY HOLDING THE RECORD RELATIONSHIP BETWEEN THE "GV" P.I. AND THE FOUND MONUMENT "I-DID" (AS SHOWN ON 2L-48) THEN IT WAS ROTATED INTO PLACE BY HOLDING THE RECORD 30 FOOT RIGHT OF WAY WIDTH ON THE NORTHERLY SIDE OF CENTER LINE FROM MONUMENT 1003 AS SHOWN ON M69-74.
