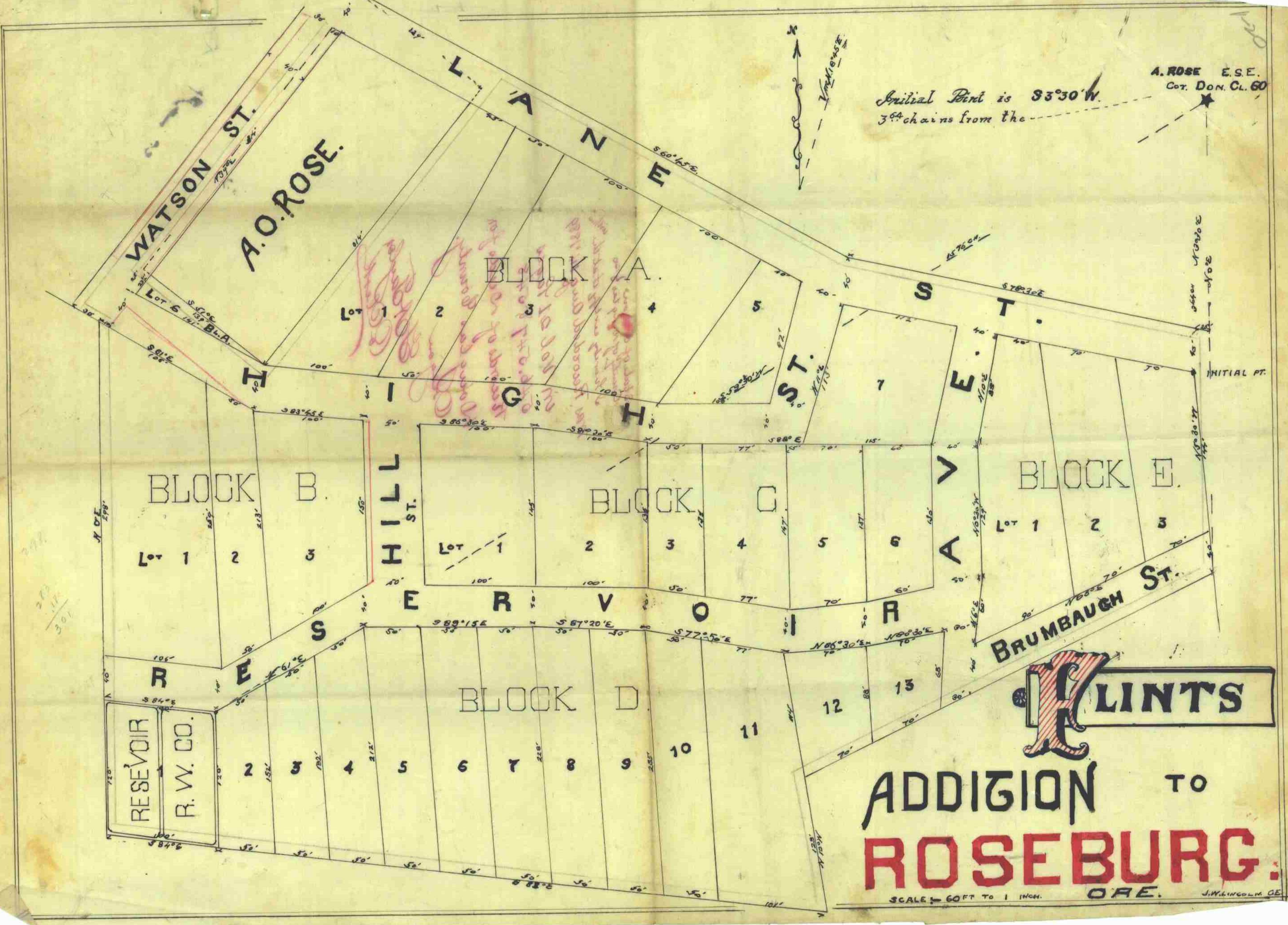

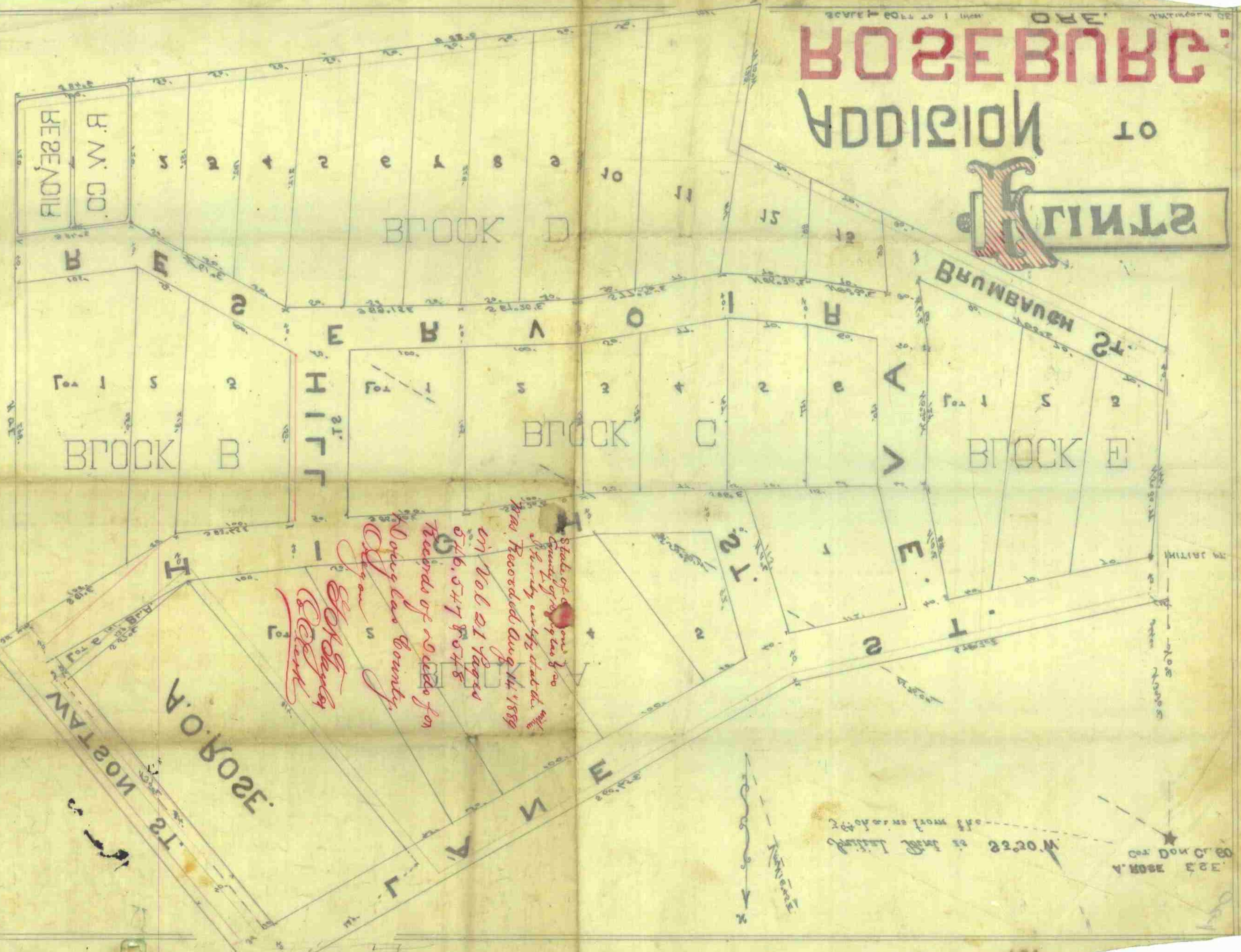

is herewith filed for record. The initial point
of said plat being a point South $3^{\circ} 20'$ West
of the most Easterly South East corner of
the Aaron Rose Donation Land Claim,
in Township 27 South, of Range 5 West, Mill
Mer. And describing by courses and distances
the Notes and Bounds of said Flint's
Addition. And Mr. S. C. Flint, and
Maria, a Flint his wife do hereby
dedicate, and convey to the General
Public, the streets and avenues, laid
off on the said premises, to wit, Lane
