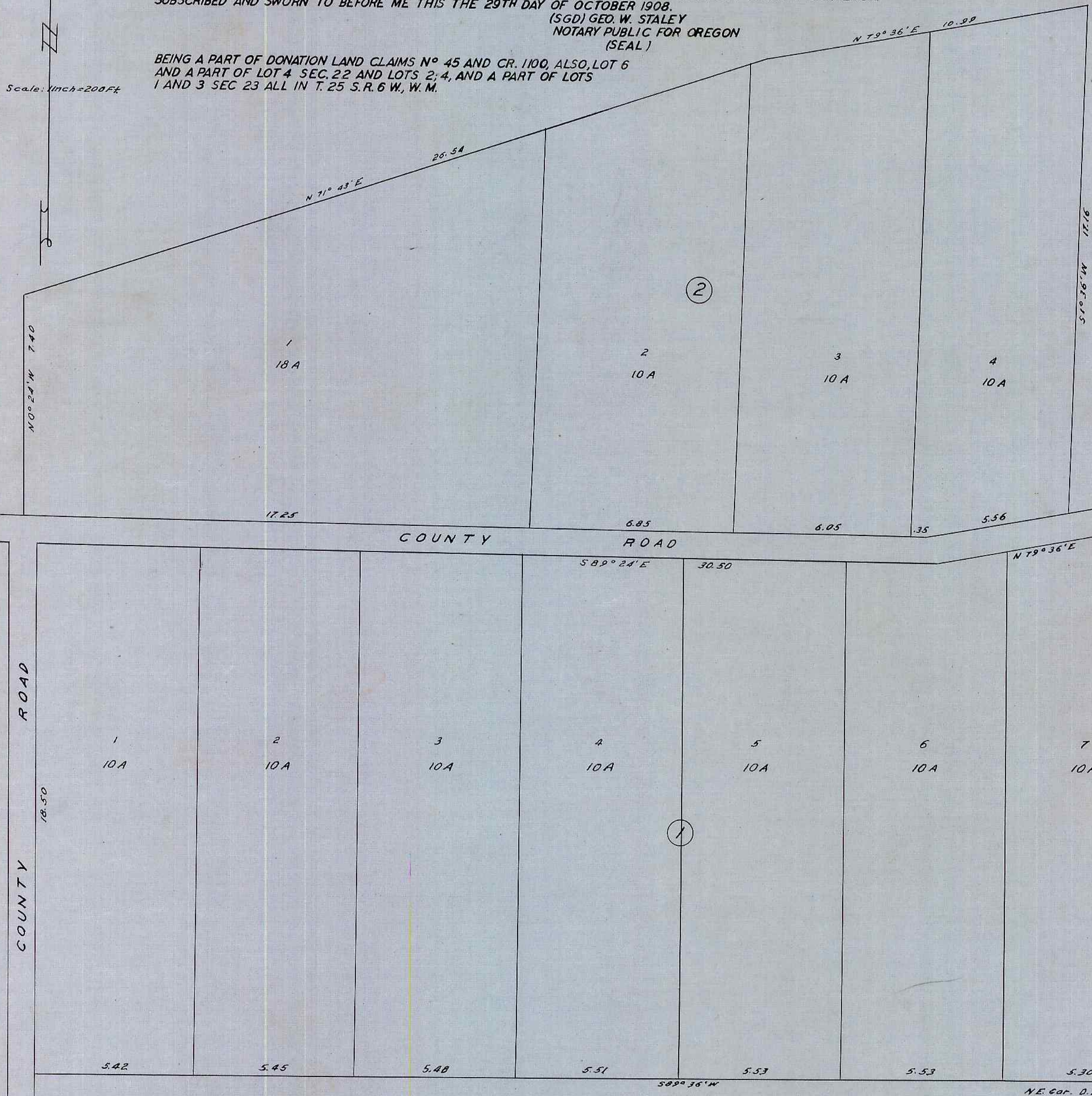

 KNOW ALL MEN BY THESE PRESENTS, THAT WE THE UNDERSIGNED, RALPH B. FISHER AND BERTHA K. FISHER, HIS WIFE OF MULTNOMAH COUNTY STATE OF OREGON, THE OWNERS OF THE LAND DESIGNATED IN THE ANNEXED PLAT, DO HEREBY DECLARE THE ANNEXED MAP TO BE A TRUE PLAT OF THE PROPERTY LAID OUT BY US AS "THE CALAPOOIA WALNUT FARM" SITUATED IN TOWNSHIP 25 S., R. 6 WEST W. M. IN DOUGLAS COUNTY STATE OF OREGON, CONSISTING OF TWO BLOCKS NUMBERED (1) AND (2) SUBDIVIDED INTO LOTS NUMBERED 1, 2, 3, 4, 5, 6 AND 7 IN BLOCK NUMBERED (1) CONTAINING TEN ACRES EACH AND LOTS NUMBERED 1, 2, 3 AND 4 IN BLOCK NUMBERED (2) CONTAINING 18, 10, 10 AND 10 ACRES RESPECTIVELY, AND WE DO HEREBY DEDICATE TO THE USE OF THE PUBLIC FOREVER THE ROAD DIVIDING SAID BLOCKS (1) AND (2) AS LAID OUT THEREIN.
