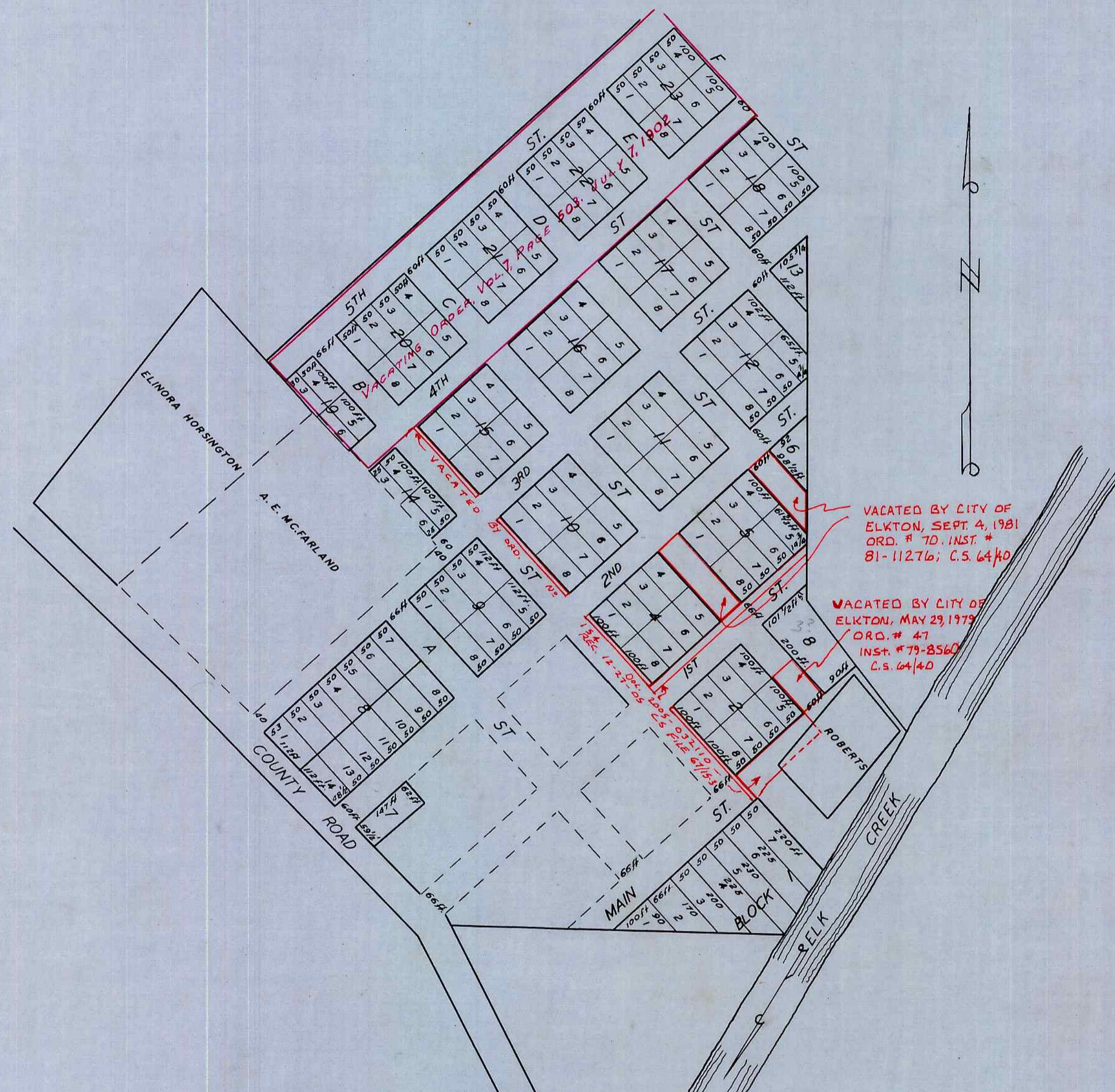


# FIRST ADDITION TO ELKTON

LEVINS, HIS WIFE DO HEREBY DEDICATE TO THE TOWN OF ELKTON AND THE GENERAL PUBLIC THE STREETS LAID OFF ON THE SAID PREMISES AS SHOWN BY THE PLAT OF THE SAID "FIRST ADDITION TO ELKTON" HEREWITH FILED FOR RECORD TO THE USE AND BENEFIT OF THE PUBLIC FOREVER.
