GABBERT OF MYRTLE CREEK DOUGLAS COUNTY, STATE OF OREGON, HAVE SURVEYED AND PLATTED AN ADDITION TO THE TOWN OF MYRTLE CREEK, DOUGLAS COUNTY OREGON, THE PLAT OF SAID ADDITION BEING HERewith FILED FOR RECORD THE SAID ADDITION TO BE KNOWN AS "GABBERTS SECOND ADDITION TO THE TOWN OF MYRTLE CREEK" THE SAID ADDITION IS LAID OUT INTO LOTS OF SIZE AND NUMBER AS APPEARS FROM SAID PLAT OF SURVEY HERETO ANNEXED AND THE SAID F. M. GABBERT DO HEREBY DEDICATE TO THE TOWN OF MYRTLE CREEK AND TO THE GENERAL PUBLIC THE STREETS AND ALLEYS LAID OFF ON THE SAID PREMISES AS SHOWN BY SAID PLAT TO THE USE AND BENEFIT OF THE PUBLIC FOREVER. 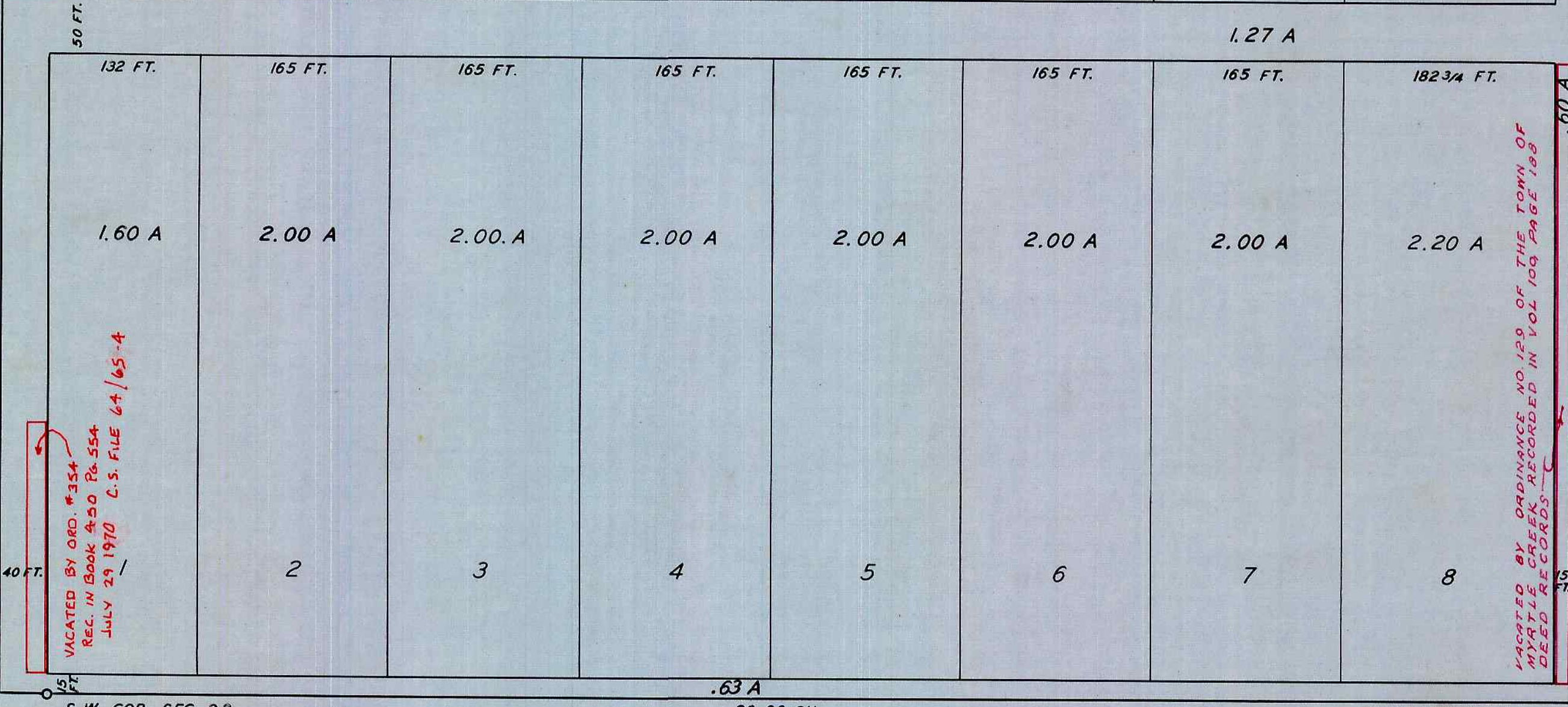
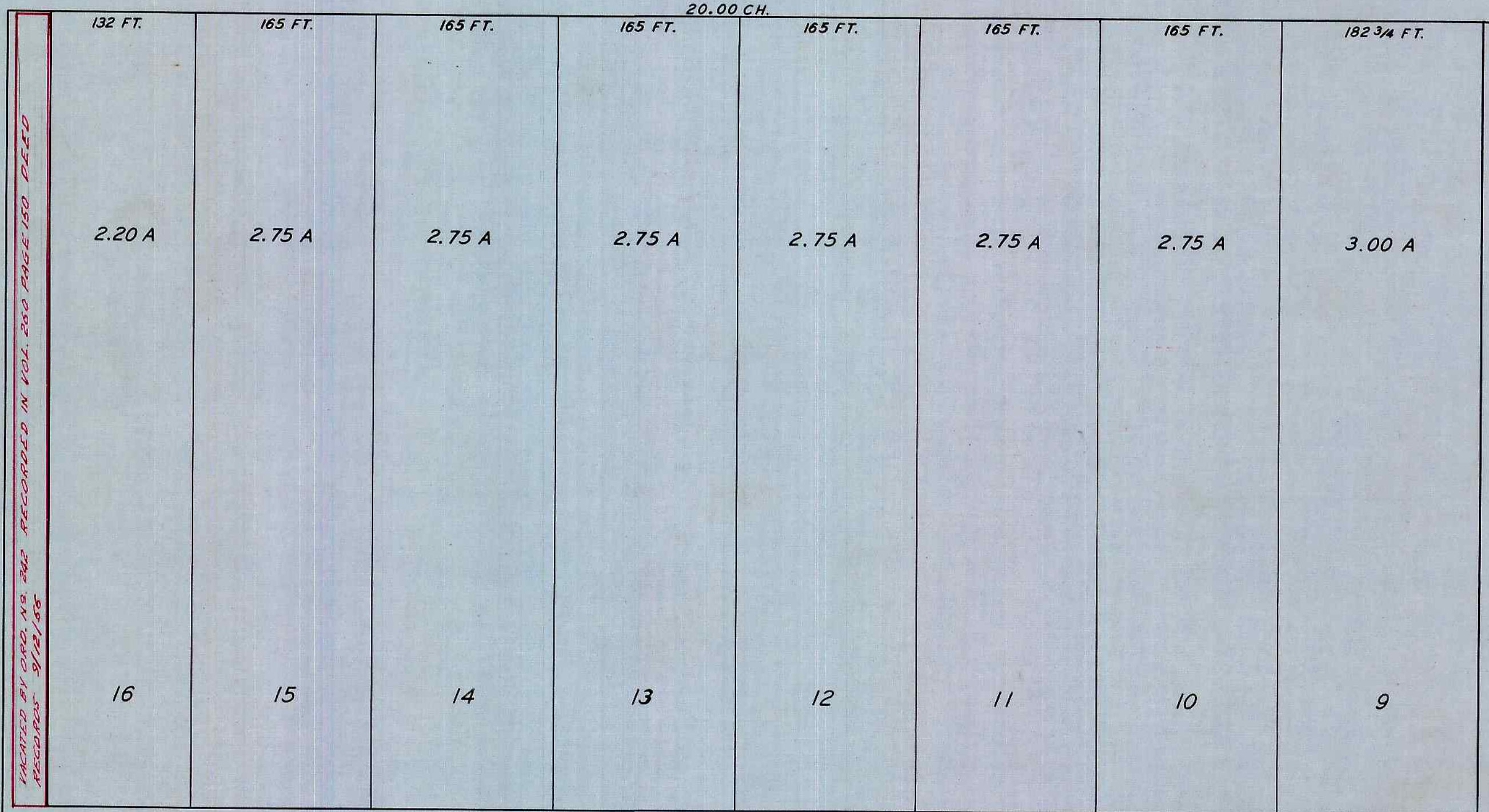
