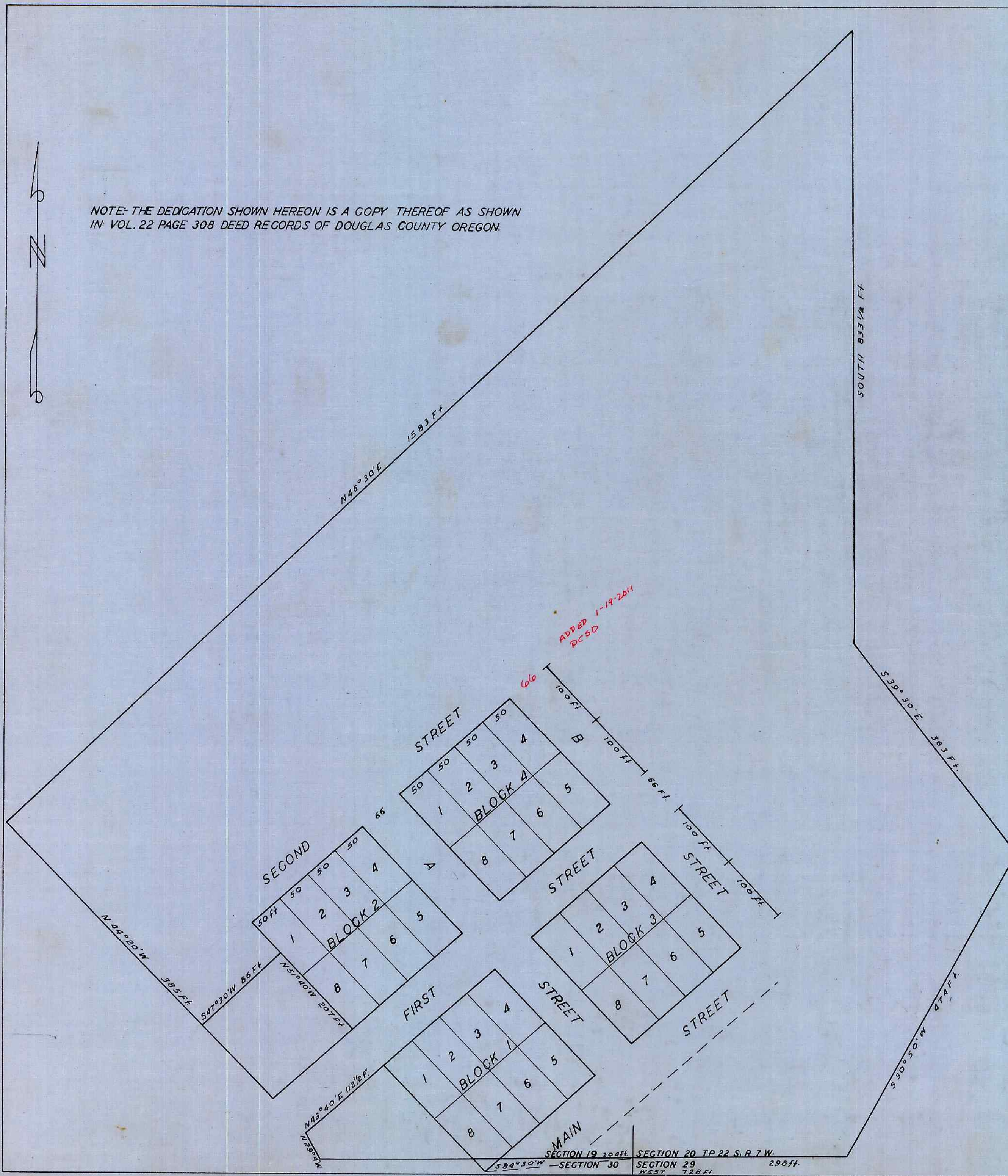


PLAT OF ELKTON DOUGLAS COUNTY OREGON

DEDICATION OF THE TOWN OF ELKTON:

KNOW ALL MEN BY THESE PRESENTS THAT MR. HENRY BECKLEY AND MARY M. BECKLEY HIS WIFE OF DOUGLAS COUNTY OREGON HAVE SURVEYED AND PLATED A TOWN IN DOUGLAS COUNTY OREGON TO BE KNOWN AS THE TOWN OF ELKTON. THE SAID TOWN IS LAID OUT INTO BLOCKS AND LOTS OF SIZE AND NUMBER AS APPEARS FROM SAID PLAT OF SURVEY HERETO ANNEXED AND THE SAID HENRY BECKLEY AND MARY M. BECKLEY HIS WIFE DO HEREBY DEDICATE TO THE TOWN OF ELKTON AND THE GENERAL PUBLIC THE STREETS LAID OFF ON THE SAID PREMISES AS SHOWN BY THE PLAT OF THE SAID TOWN OF ELKTON HEREWITH FILED FOR RECORD TO THE USE AND BENEFIT OF THE PUBLIC FOREVER IN WITNESS WHEREOF WE HAVE HEREUNTO SET OUR HANDS AND SEALS THIS 27th DAY OF DECEMBER 1889.
