STEARNS HAVE CAUSED THE TRACT OF LAND REPRESENTED ON THE MAP HEREON TO BE SURVEYED AND LAID OFF IN LOTS AS REPRESENTED NUMBERS FROM ONE (1) TO TWENTY (20) AND THE MEASUREMENTS ARE SHOWN BY FIGURES REPRESENTING CHAINS AND LINKS, AND WE THE SAID DORAN H. STEARNS AND A. ELLA S. STEARNS DO HEREBY DEDICATE TO THE USE OF THE PUBLIC FOREVER THE STREET 30 FEET WIDE AS SHOWN ON THE MAP ON AND OVER SAID LAND SO FAR AS WE OR EITHER OF US HAVE ANY INTEREST RIGHT OR TITLE THEREIN.
