

MAP OF LONDON AND WHEELER'S ADDITION No 1

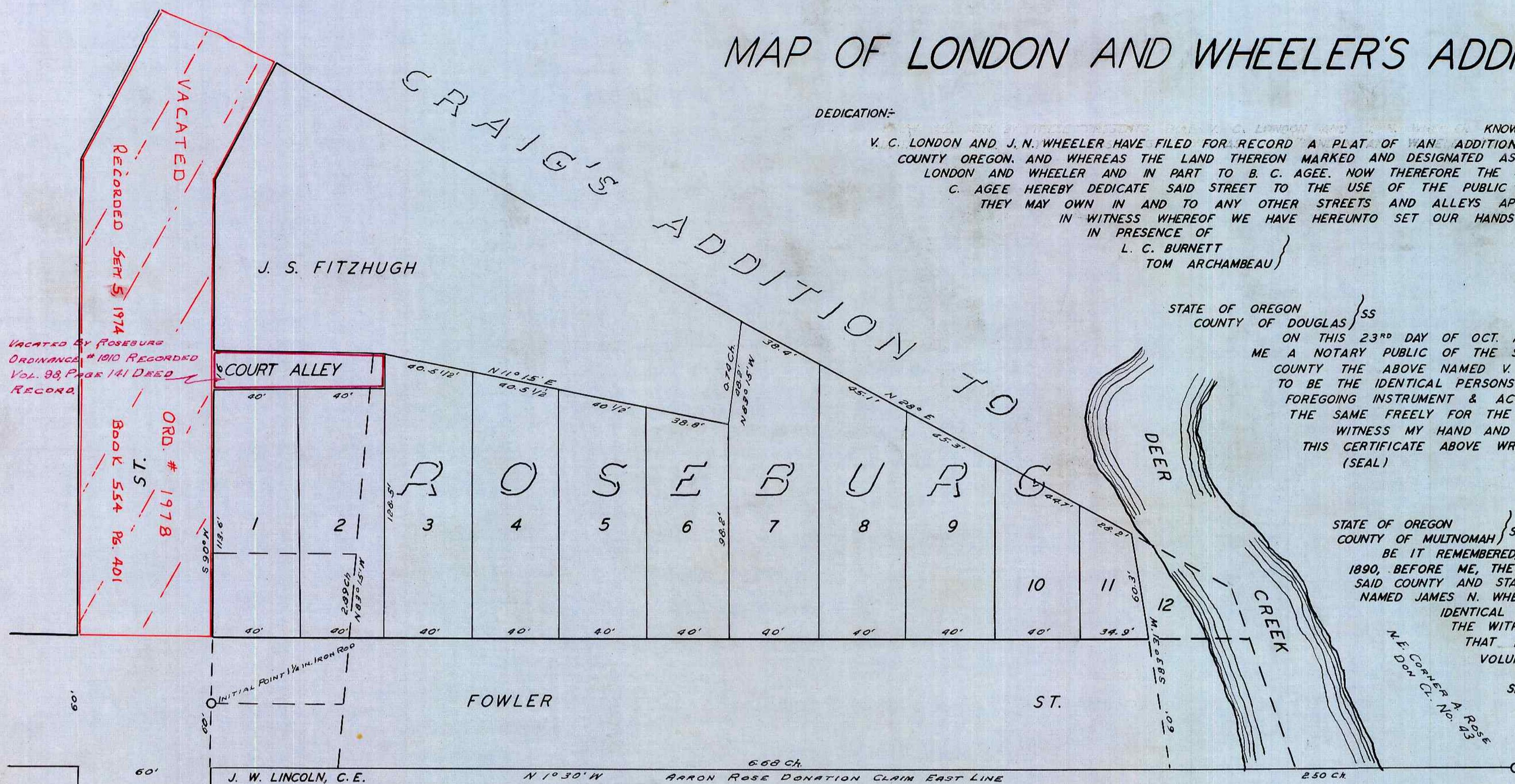
DEDICATION:-

KNOW ALL MEN BY THESE PRESENTS THAT V. C. LONDON AND J. N. WHEELER HAVE FILED FOR RECORD A PLAT OF AN ADDITION TO THE CITY OF ROSEBURG DOUGLAS COUNTY OREGON. AND WHEREAS THE LAND THEREON MARKED AND DESIGNATED AS FOWLER STREET, BELONGS IN PART TO LONDON AND WHEELER AND IN PART TO B. C. AGEE. NOW THEREFORE THE SAID V. C. LONDON, J. N. WHEELER AND B. C. AGEE HEREBY DEDICATE SAID STREET TO THE USE OF THE PUBLIC FOREVER, AND ALSO WHATEVER INTEREST THEY MAY OWN IN AND TO ANY OTHER STREETS AND ALLEYS APPEARING UPON SAID PLAT.
