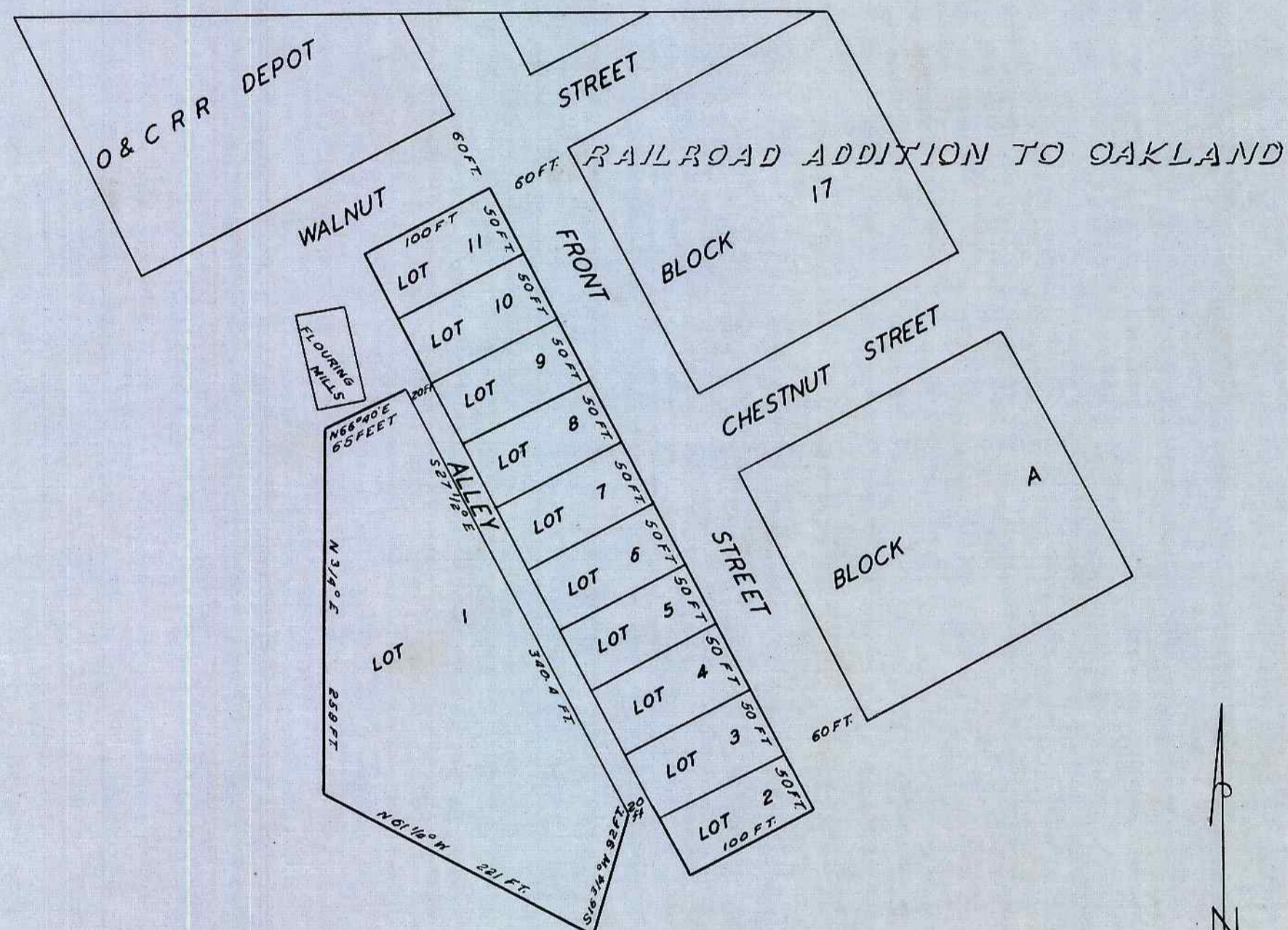


MILL ADDITION TO OAKLAND

DEDICATION:-

ON THIS 11TH DAY OF FEBRUARY, A. D. 1892 WE A. F. BROWN AND ADDIE E. BROWN OF THE COUNTY OF DOUGLAS AND STATE OF OREGON HAVE CAUSED TO BE LAID OUT THE FOLLOWING PARCEL OF LAND TO-WIT. BEGINNING AT A POINT ON THE SOUTH WEST CORNER OF FRONT AND WALNUT STREET IN THE RAILROAD ADDITION TO OAKLAND; THENCE SOUTHERLY ALONG THE WEST LINE OF FRONT STREET FIVE HUNDRED FEET (500); THENCE WESTERLY AT A RIGHT ANGLE WITH FRONT STREET ONE HUNDRED FEET (100); THENCE NORTHERLY PARALLEL WITH FRONT STREET SIXTY (60) FEET; THENCE WESTERLY TWENTY FEET (20); THENCE SOUTH $16\frac{1}{4}^\circ$ WEST NINETY TWO FEET TO THE NORTH WEST CORNER OF LANDS DEEDED BY SAID BROWN TO GEO. J. STEARNS; THENCE NORTH $61\frac{1}{4}^\circ$ WEST 221 FEET TO THE COUNTY ROAD; THENCE NORTH $\frac{3}{4}^\circ$ EAST ALONG COUNTY ROAD TWO HUNDRED FIFTY EIGHT FEET (258 FT.); THENCE NORTH $66^\circ 40'$ EAST EIGHTY FIVE FEET; THENCE NORTHERLY ONE HUNDRED FEET FROM AND PARALLEL WITH FRONT STREET ONE HUNDRED FEET TO SOUTH LINE OF WALNUT STREET; THENCE EASTERLY ALONG SAID SOUTH LINE OF WALNUT STREET TO PLACE OF BEGINNING. SITUATED IN SECTION 4, TOWNSHIP 25 S., R. 5 WEST OF THE WILLAMETTE MERIDIAN, TO BE KNOWN AND DESIGNATED AS MILL ADDITION TO OAKLAND. THE ALLEY IS TWENTY FEET WIDE, THE LOTS ARE NUMBERED FROM ONE TO ELEVEN INCLUSIVE, ALL THE LOTS EXCEPT LOT NO 1 IS 50 X 100 FT. ALL THE LOTS AND THE ALLEY ARE CORRECTLY SHOWN UPON THE ATTACHED DIAGRAM.
