

MAPLE PARK ADDITION TO RIDDLE OR.

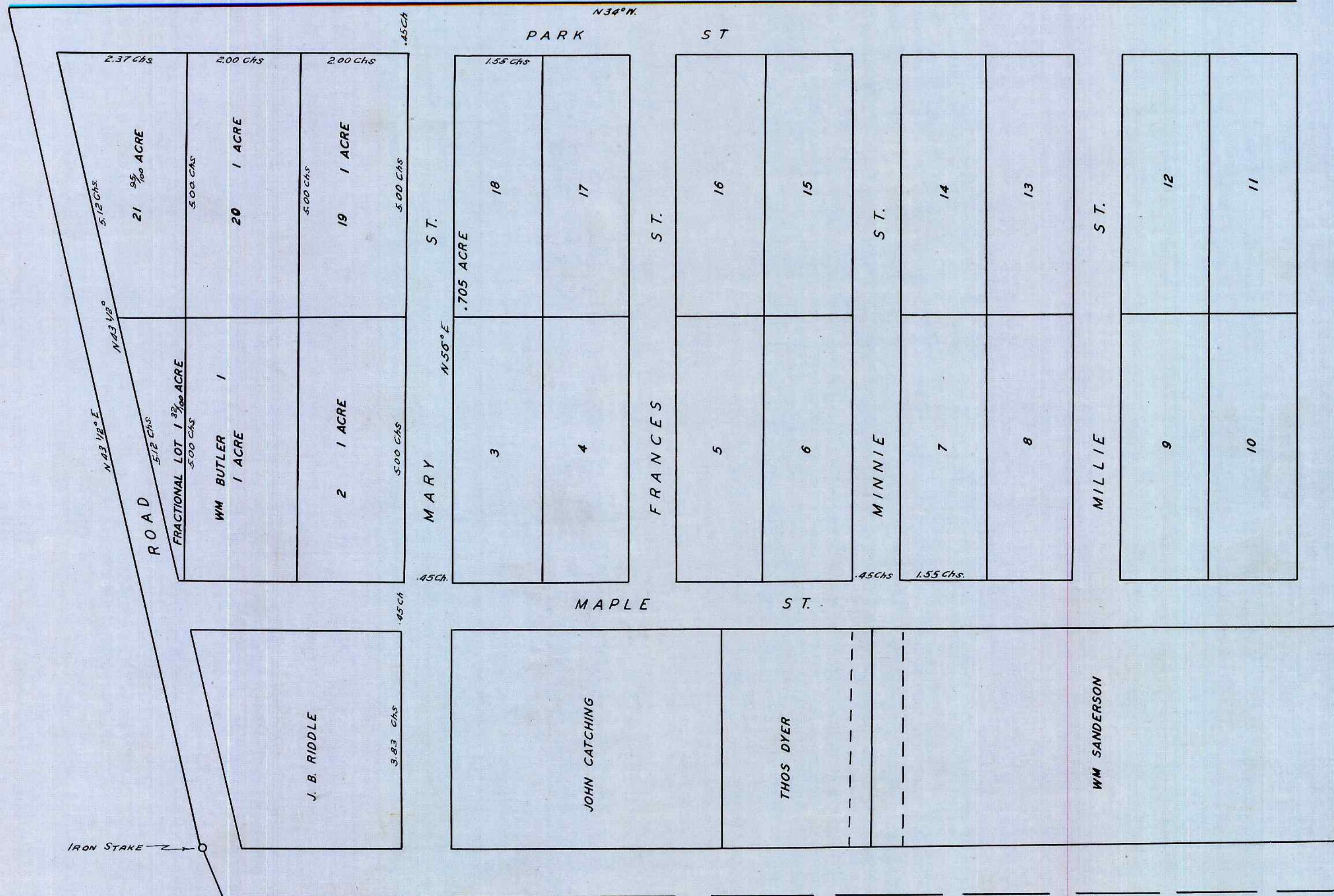
DEDICATION-
