THE STREETS ARE ALL 60 FT. WIDE EXCEPT LOCUST WHICH IS 80' WIDE. THE LOTS ARE 50 X 100 FEET EXCEPT LOTS 1 & 2 IN BLOCKS 17 & 19 WHICH ARE 60 X 100' AND LOT 9 IN EACH BLOCK WHICH ARE 20 X 200 FT. AND IS TO BE USED AS A LOT OR ALLEY AS THE OWNERS OF THE LOTS IN EACH BLOCK MAY DESIRE. ALL THE LOTS BLOCKS AND STREETS ARE CORRECTLY SHOWN ON THE ATTACHED PLAT.
