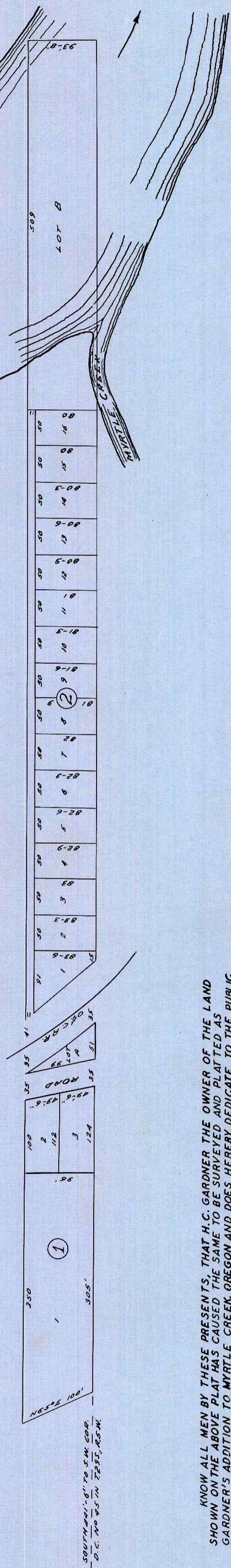
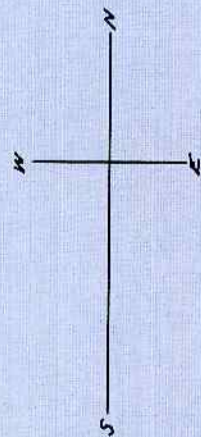


GARDNER'S ADDITION TO MYRTLE CREEK
