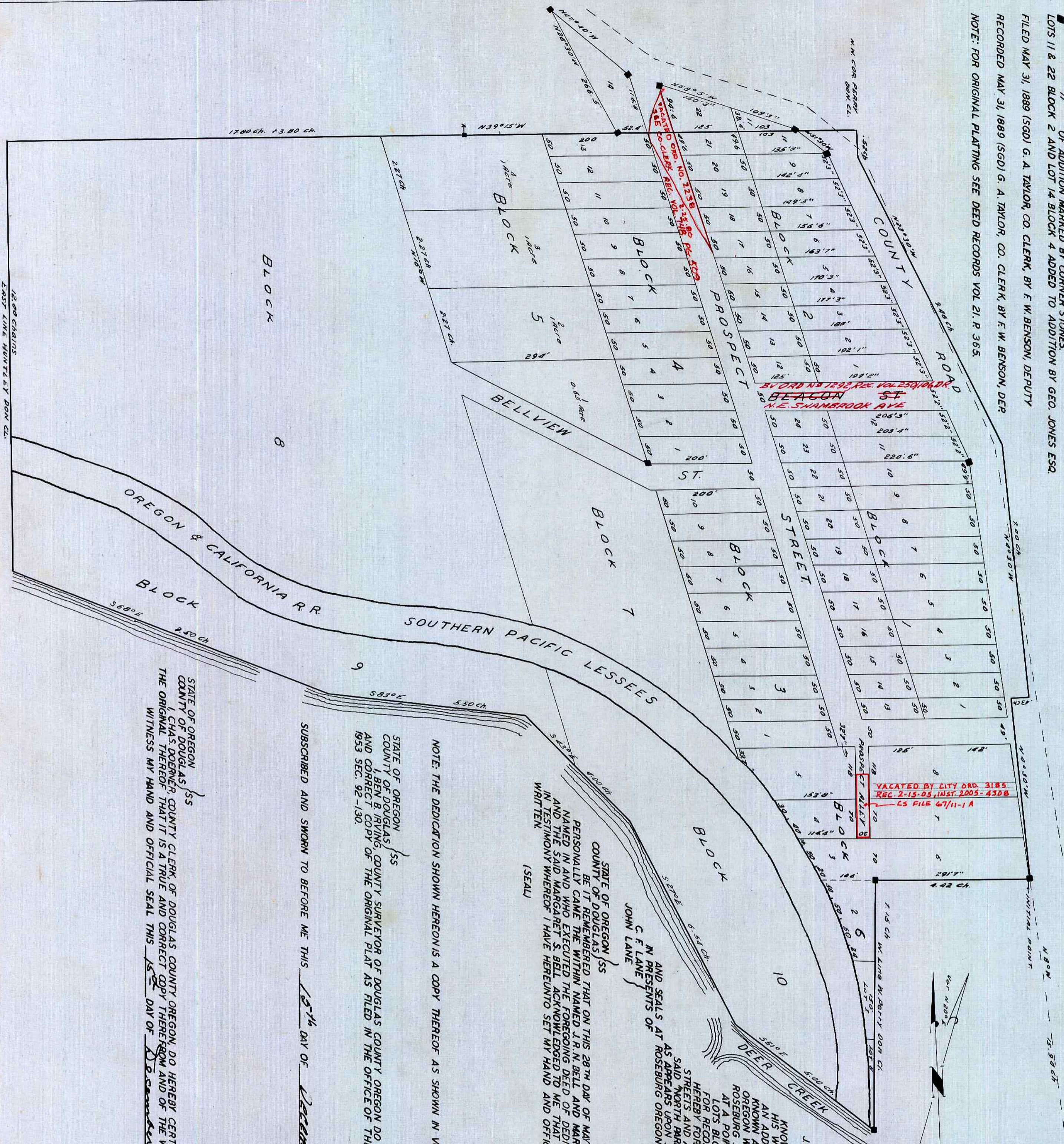

# NORTH PARK ADDITION TO THE CITY OF ROSEBURG

J. R. N. BELL & WIFE, DEDICATOR & PLAT NORTH PARK ADDITION TO ROSEBURG—

KNOW ALL MEN BY THESE PRESENTS THAT WE J. R. N. BELL AND MARGARET S. BELL HIS WIFE OF DOUGLAS COUNTY STATE OF OREGON HAVE SURVEYED AND PLATTED AN ADDITION TO THE CITY OF ROSEBURG DOUGLAS COUNTY STATE OF OREGON TO BE KNOWN AS "THE NORTH PARK ADDITION" TO THE CITY OF ROSEBURG DOUGLAS COUNTY OREGON WHICH IS HEREBY FILED FOR RECORD. THE SAID ADDITION TO THE CITY OF ROSEBURG SO SURVEYED AND PLATTED FOR RECORD WITH SAID CITY AS FOLLOWS TO WIT:

AT A POINT MARKED AND INDICATED ON SAID PLAT OF SURVEY AND IS LAID OFF IN TO LOTS BLOCKS STREETS AND ALLEYS AS SHOWN BY THE SAID PLAT HEREBY FILED FOR RECORD AND WE THE SAID J. R. N. BELL AND MARGARET S.
