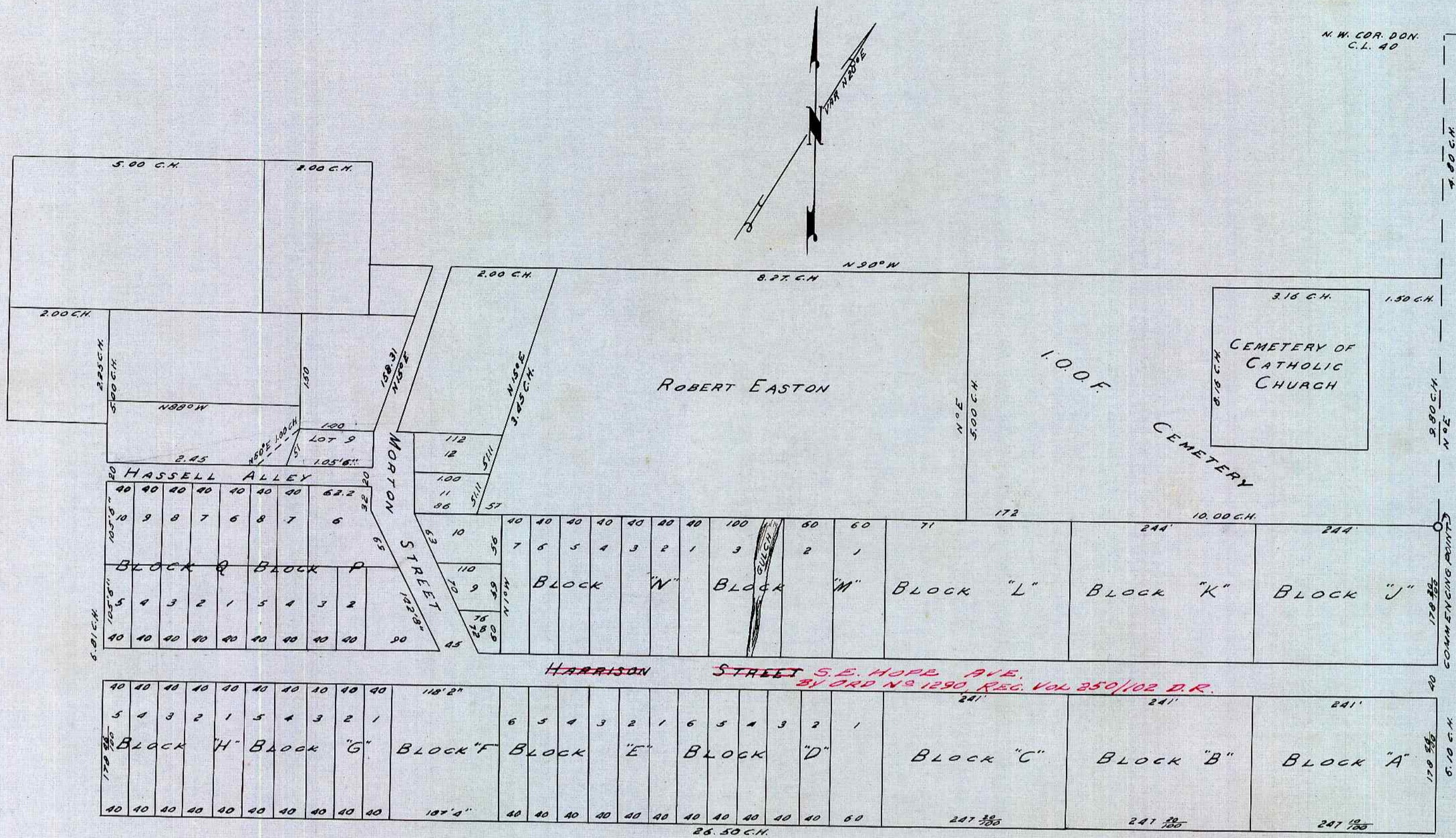


HASSELL'S ADDITION TO ROSEBURG

HASSELL OWNERS OF HASSELL'S ADDITION TO THE CITY OF ROSEBURG, DOUGLAS COUNTY OREGON DO HEREBY FILE THIS PLAT OF THE SURVEY OF SAID ADDITION TO THE CITY OF ROSEBURG AFORESAID WITH THE CLERK OF SAID COUNTY AND DO HEREBY DEDICATE TO THE PUBLIC USE AS THE LAW REQUIRES ALL THE STREETS AND ALLEYS IN SAID PLAT DESCRIBED.
