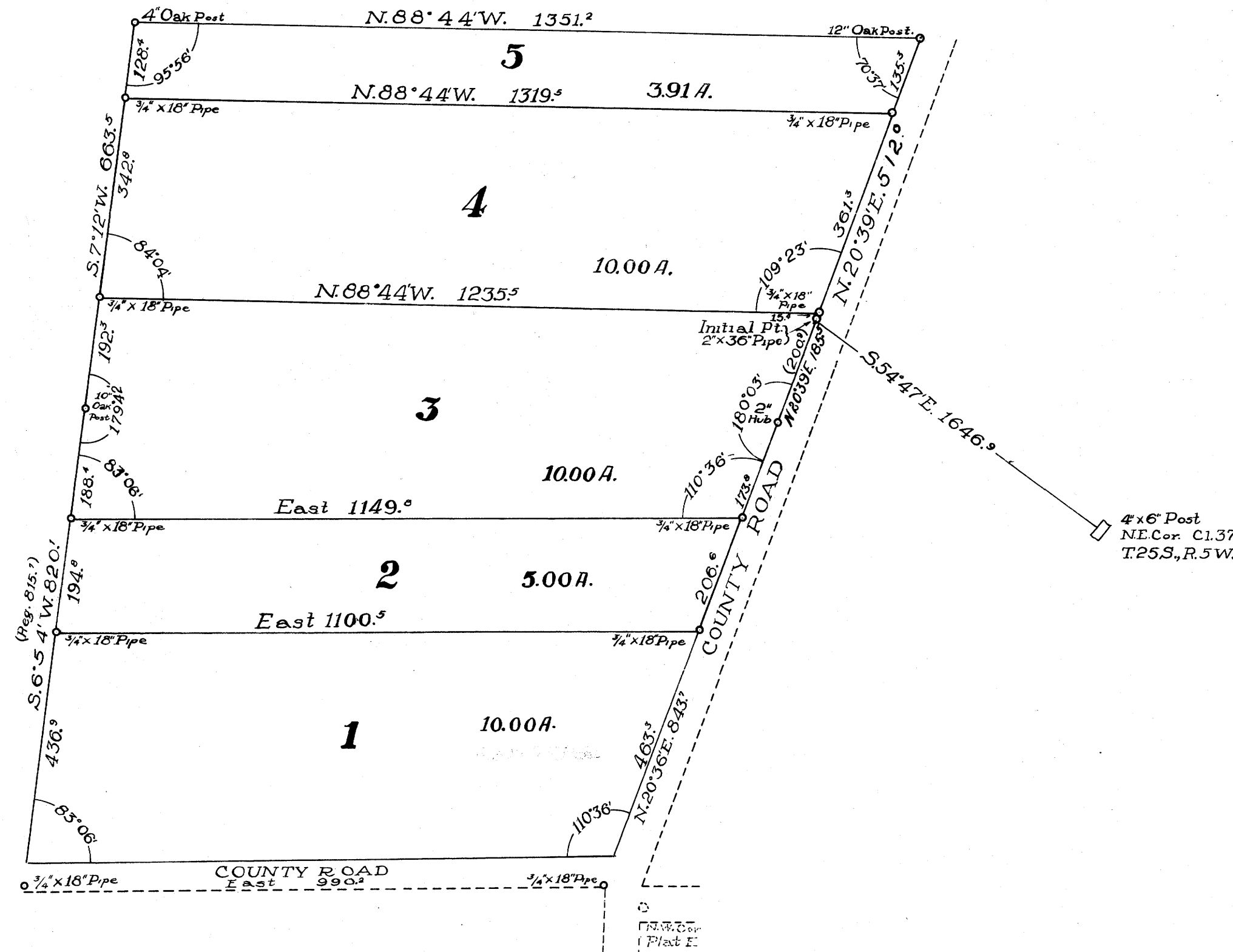
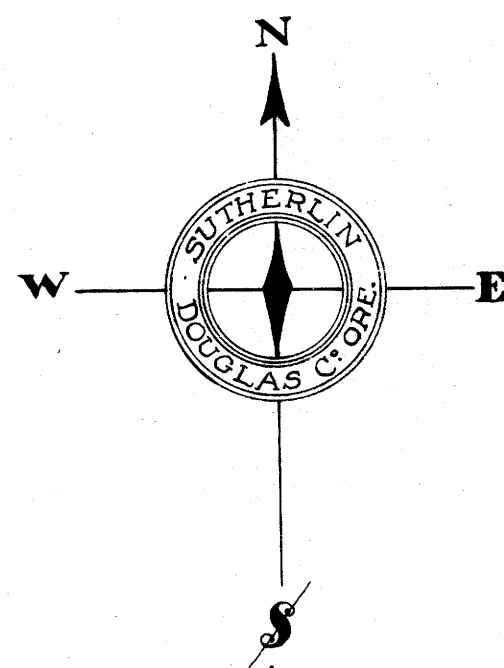
I, Sidney Strong being duly sworn, depose and say that I am Chief Engineer of The Sutherlin Land & Water Co., a corporation duly incorporated and existing under and by virtue of the Laws of the State of Oregon, that I have had surveyed under my direction the tract of land shown on the above plat, and known as Plat L of The Sutherlin Land & Water Co; that the survey and plat are correct and that the corners and lots have been marked with proper monuments, as directed by Law; I have had set an initial point, a two inch by thirty-six inch galvanized pipe from which the N.E. Cor. of Donation Land, Cl. No. 37, T. 25 S. R. 3 W., bears S. 34° 47' E. 1646.3 ft; thence N. 20° 39' E. 512.7 ft. to the N.E. Cor. Plat L, a 12" Oak post; thence N. 68° 44' W. 1351.2 ft. to the N.W. Cor. Plat L, a 4" Oak post; thence S. 7° 12' W. 663.2 ft. to a 10" Oak post; thence S. 6° 54' W. 820.1 ft. to the S.W. Cor. Plat L, a 3/4" x 18" pipe in County Road; thence East 990.2 ft. to the S.E. Cor. Plat L, a 3/4" x 18" pipe in County Road; thence N. 20° 36' E. 843.7 ft. to a 2" Hub; thence N. 20° 39' E. 165.2 ft. to point of beginning.

I also swear that the sub-division is correct as shown by plat, which is a correct map of the sub-division.
