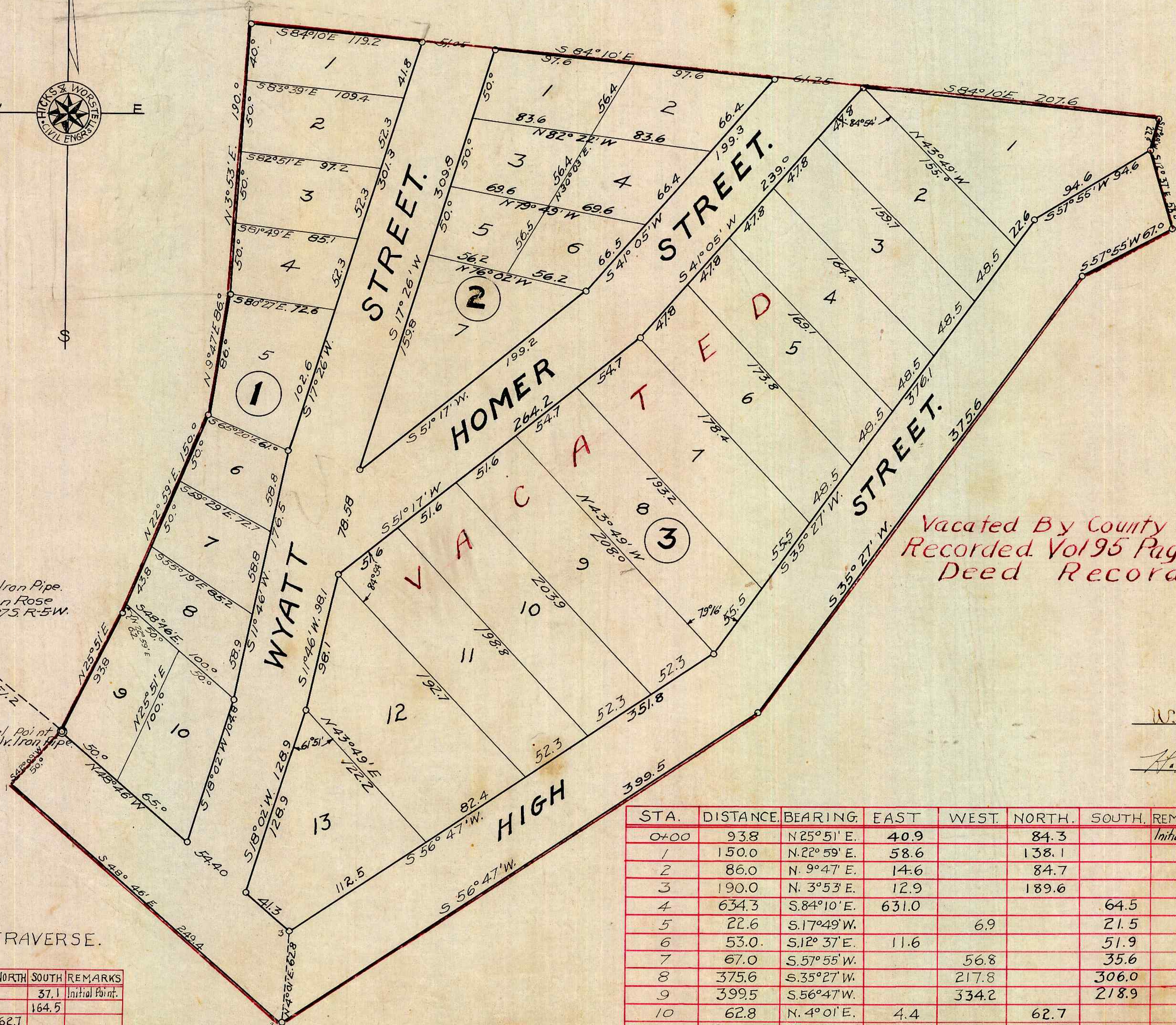
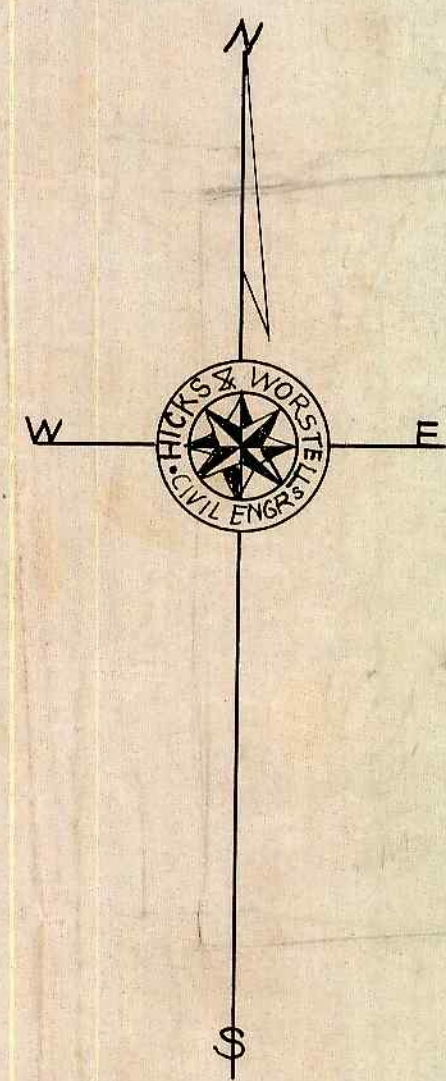


MILLER'S PLAT "B" ADDITION TO THE CITY OF ROSEBURG, ORE.
