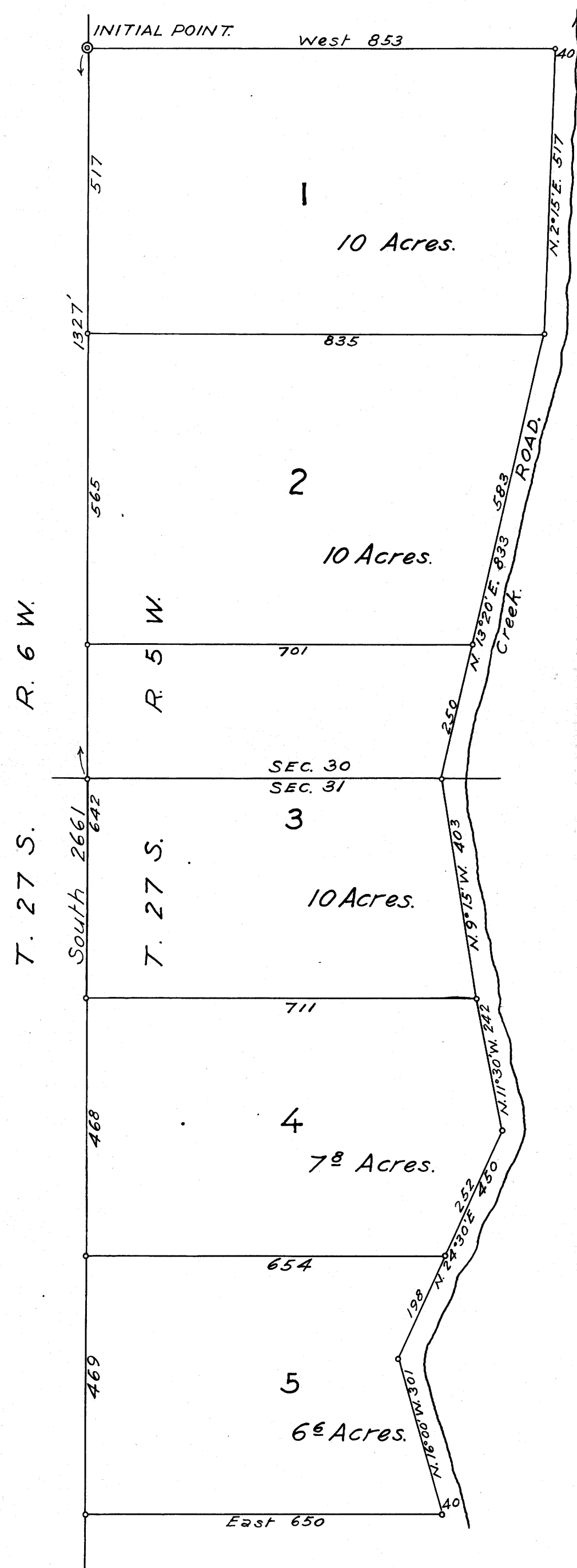
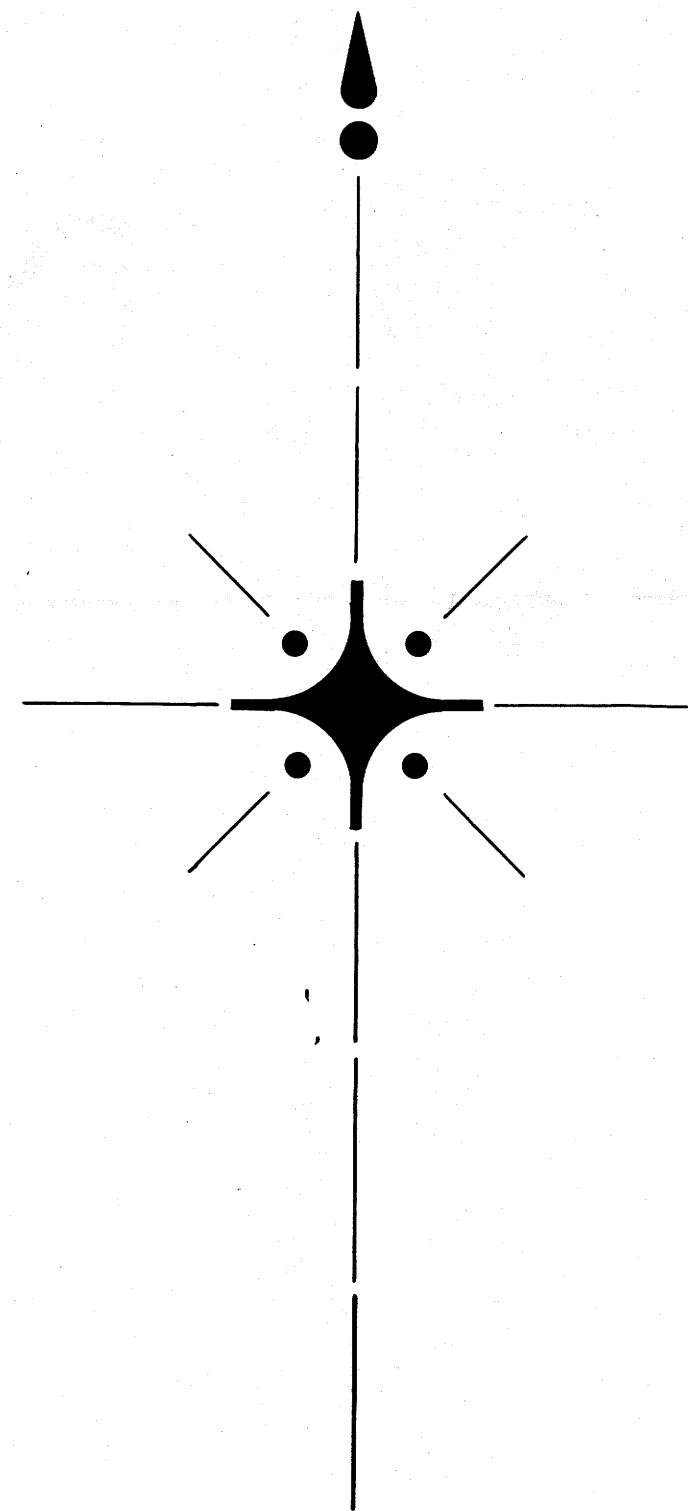


WEISS HOME TRACTS

CERTIFICATE OF SURVEYOR.

I, C. C.
