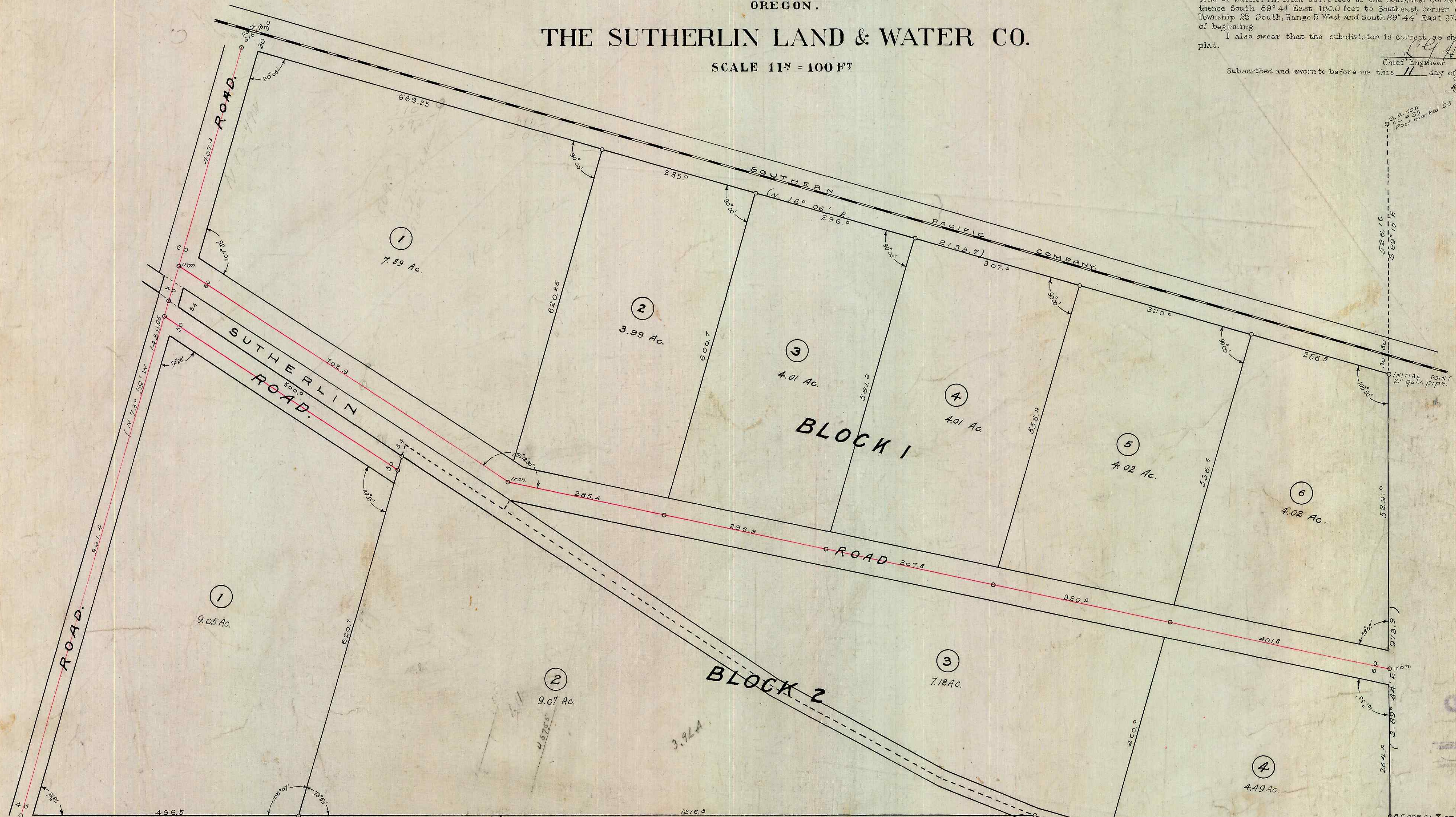

I, L. G. Hicks, being duly sworn, depose and say that I am the Chief Engineer of The Sutherlin Land & Water Company, a corporation existing under and by virtue of the Laws of the State of Oregon; that I have had surveyed, under my direction, the tract of land shown on the above plat and known as Plat "H" of The Sutherlin Land & Water Company, that the survey and plat are correct and that the corners and lots have been marked with proper monuments, as directed by Law. I have had set an initial point, being the Southeast corner of Plat "H", from which the Southeast corner of Claim No. 39, a post marked "C.S.", Township 25 South, Range 5 West of the Willamette Meridian, Douglas County, State of Oregon, bears South 89° 15' East a distance of 526.0 feet, thence North 16° 06' East 2132.7 feet to the Northeast corner of Plat "H" a rock 6' 6" x 18" in.; thence North 73° 59' West - 1439.65 feet to Northwest corner of said Plat "H", thence South 0° 06' West 1612.8 feet to center of Sutherlin Creek, thence South 16° 01' West along the center line of Sutherlin Creek 661.0 feet to the Southwest corner of Plat "H", thence South 89° 44' East 180.0 feet to Southeast corner of Claim No. 37, Township 25 South, Range 5 West and South 89° 44' East 973.9 to point of beginning.

I also swear that the sub-division is correct as shown on above plat.

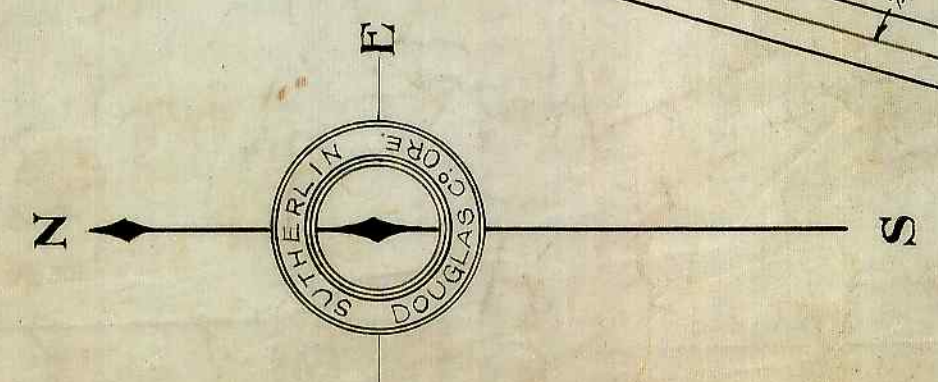
