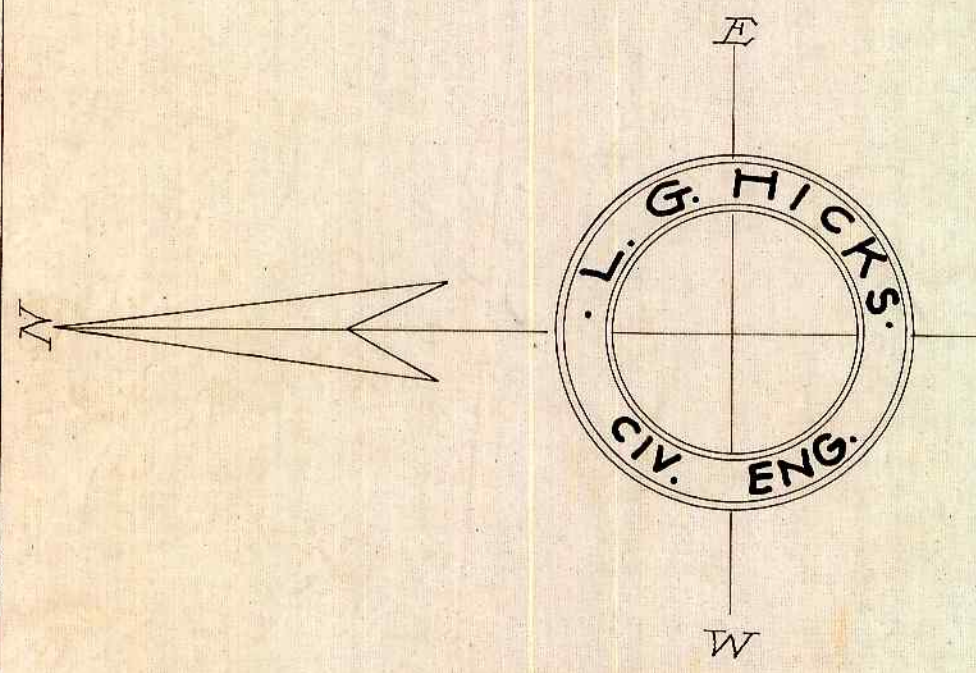

OREGON.



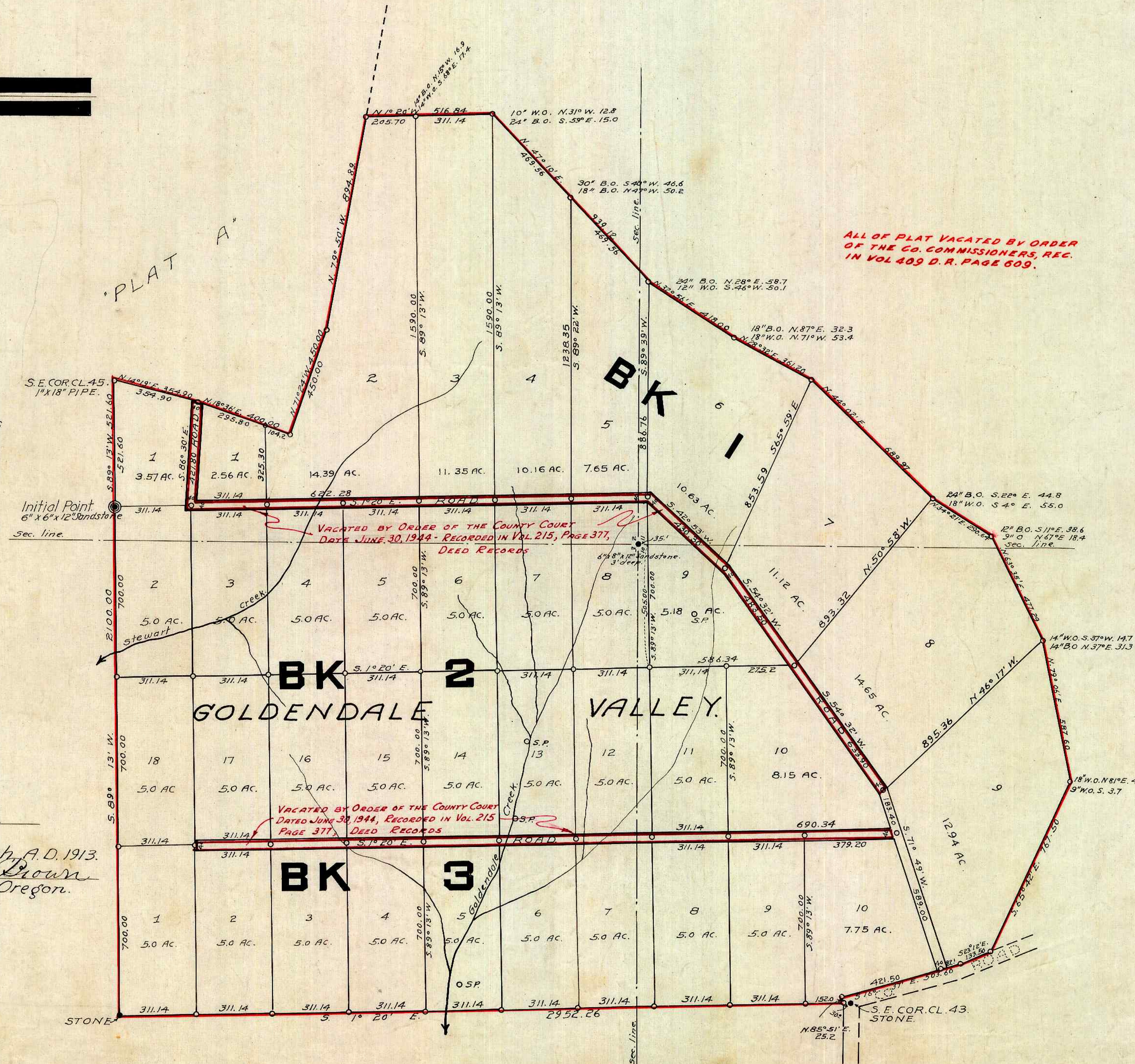
