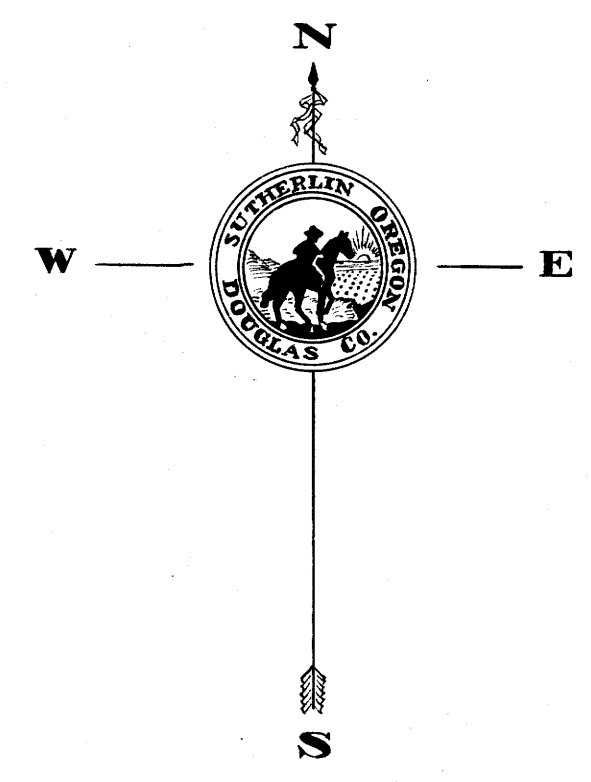
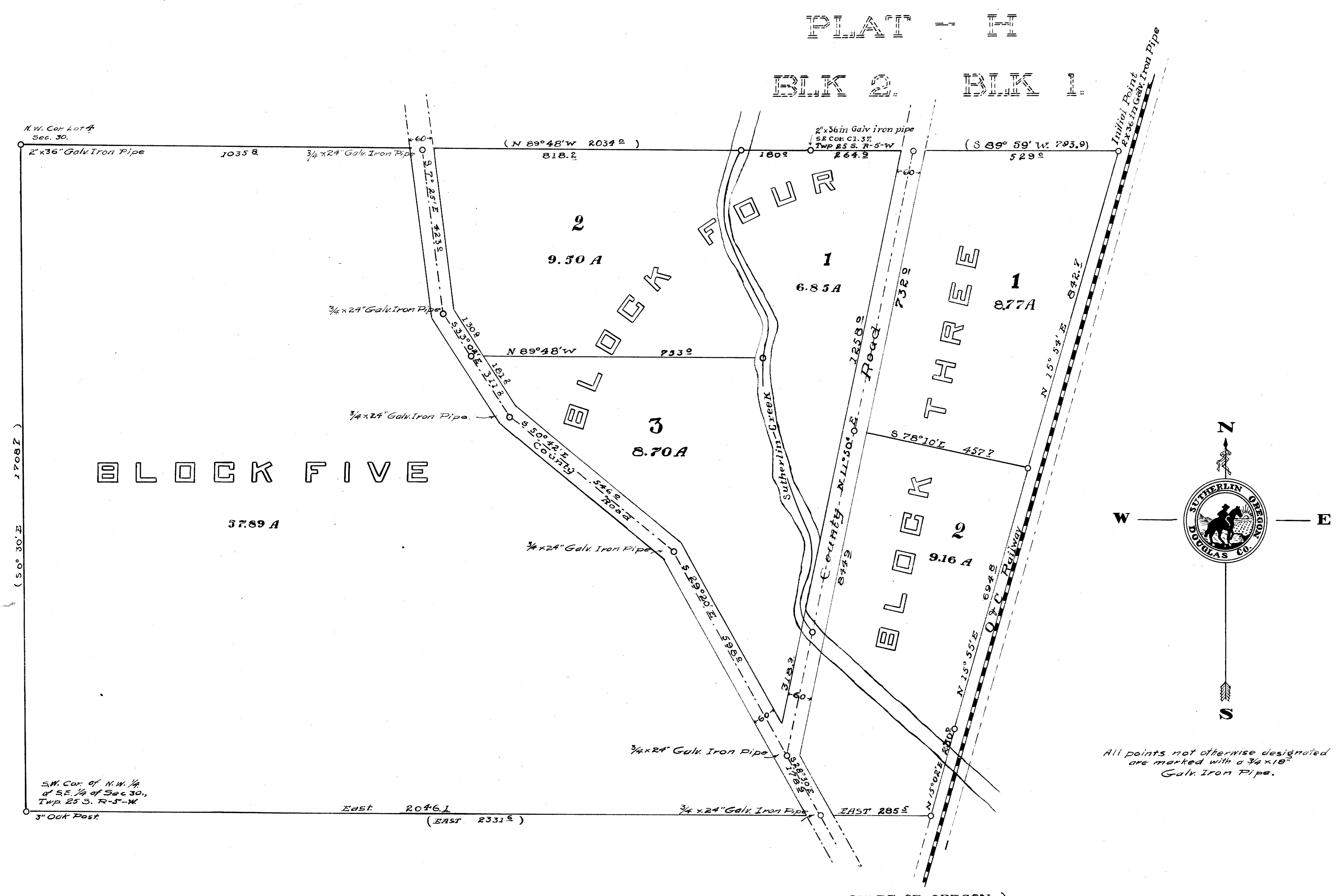
BLOCKS 3, 4 & 5

I have had set an Initial Point a 2 in. by 36 in. Galv. Iron Pipe, the N.E. Cor. of Blk 3, Plat "H" from which a 2 in. by 36 in. Galv. Iron Pipe the S.E. Cor. of Bl. 37, Twp. 25 S. R. 5 W., Willamette Meridian, County of Douglas State of Oregon, bears S 69° 59' W. 793.9 Ft.; thence S 69° 59' W. 793.9 Ft. to a 2 in. by 36 in. Galv. Iron pipe, the S.E. Cor. of Bl. 37, Twp. 25 S. R. 5 W.; thence N 89° 48' W. 2034.0 Ft. to a 2 in. by 36 in. Galv. Iron pipe the N.W. Cor., Lot 4, Sec. 30, the N.W. Cor. Blk 3, Plat "H"; thence S 69° 59' E. 1708.7 Ft. to a 3 in. Oak post, the S.W. Cor. of the N.W. 1/4 of the S.E. 1/4 of Sec. 30, the S.W. Cor. Blk 3, Plat "H"; thence East 2331.6 Ft. to a 3/4 in. by 2 1/2 in. Galv. Iron pipe, on west boundary of the 3/4 in. Right of Way, the S.E. Cor. Blk 3, Plat "H"; thence N. 15° 02' E. 230.0 Ft. to a 3/4 in. by 2 1/2 in. pipe on west boundary of O.P.C. Right of Way; thence N. 15° 35' E. 694.8 Ft. to a 3/4 by 2 1/2 in. pipe, the S.E. Cor. Lot 1, Block 3; thence N. 15° 54' E. 642.7 Ft. to the point of beginning.
